## TEXAS COMMISSION ON ENVIRONMENTAL QUALITY



AN INTERIM ORDER regarding the joinder petition by Restore the Grasslands, LLC, for the creation of Collin County Municipal Utility District No. 7; TCEQ Docket 2022-0533-DIS.

On May 22, 2025, the Texas Commission on Environmental Quality (Commission) considered during its open meeting several requests for hearing and reconsideration concerning the joinder petition (petition) by Restore the Grasslands, LLC (Petitioners) for the creation of Collin County Municipal Utility District No. 7 (District) in Collin County. The hearing requests and requests for reconsideration were evaluated under the requirements in the applicable statutes and Commission rules, including 30 Texas Administrative Code Chapter 55, Subchapter G. <sup>1</sup> The Commission also considered the responses to the hearing requests filed by the Executive Director, the Office of Public Interest Counsel, and Applicant; timely filed replies, and timely public comment.

After evaluation of all relevant filings, the Commission determined to grant the hearing requests of those individuals and entities in the attached document, labeled, "TCEQ Docket No. 2022-0533-DIS Order: Granted Hearing Requests" and denied the remaining hearing requests and requests for reconsideration.

2. All remaining hearing requests and requests for reconsideration are hereby DENIED;

3. The Chief Clerk shall REFER this matter to SOAH for a contested case hearing on the

petition; and

4. If any provision, sentence, clause, or phrase of this Order is for any reason held to be

invalid, the invalidity of any portion shall not affect the validity of the remaining portions

of the Order.
