NOTICE OF HEARING James L. Davis SOAH Docket No. 582-24-11816 TCEQ Docket Nos. 2024-0174-LIC and 2024-0177-LIC

APPLICATION.

James L. Davis, 3200 X A Meyer Road, Granbury, Texas, 76049, has applied to the Texas Commission on Environmental Quality (TCEQ) for renewals of an On-Site Sewage Facility (OSSF) Installer II License and an OSSF Maintenance Provider License. The Executive Director denied Mr. Davis's applications for cause. Mr. Davis has requested a formal hearing on the Executive Director's decisions. During the review of Mr. Davis's applications, the Executive Director became aware that Mr. Davis has continually received citations from Erath County in activities related to OSSF. The Executive Director denied Mr. Davis's applications because of his record in the preceding five years of statutes or rules as referenced in Texas Water Code (TWC) § 37.005(c)(1) and he has demonstrated gross negligence, incompetence, or misconduct in the performance of activities authorized by the licenses as referenced in TWC Code § 57.005(c)(3).

CONTESTED CASE HEARING.

The State Office of Administrative Hearings (SOAH) will conduct a preliminary hearing via Zoom videoconference. A Zoom meeting is a secure, free meeting held over the internet that allows video, audio, or audio/video conferencing.

The purpose of a preliminary hearing is to establish jurisdiction, name the parties, establish a procedural schedule for the remainder of the proceeding, provide an opportunity for settlement discussions, and address other matters as determined by the administrative law judge. The preliminary hearing will be held unless all timely hearing requests are withdrawn or the parties agree to waive the preliminary hearing.

The evidentiary phase of the contested case hearing, to be held at a later date, will be a legal proceeding similar to a civil trial in state district court to determine whether Mr. Davis should be issued renewals of an OSSF Installer II License and an OSSF Maintenance Provider License. Unless agreed to by all parties in attendance at the preliminary hearing, an evidentiary hearing will not be held on the date of this preliminary hearing. If Mr. Davis fails to appear at the preliminary hearing or evidentiary hearing, the Executive Director will request that the hearing be canceled, and that appeal of the Executive Director's decision be dismissed.

Legal Authority: Texas Water Code Chapters 5 and 37; Texas Occupations Code Chapter 53; Texas Government Code, Chapter 2001; 30 Texas Administrative Code (TAC) Chapter 30, and the procedural rules of the TCEQ and SOAH, including 30 TAC Chapters 70 and 80 and 1 TAC Chapter 155.
