NOTICE OF HEARING Tony Mewis SOAH Docket No. 582-24-21189 TCEQ Docket Nos. 2024-0878-LIC

APPLICATION.

Tony Mewis, 30902 Bluebonnet Lane, Texas, 77354, has applied to the Texas Commission on Environmental Quality (TCEQ) for an On-Site Sewage Facility (OSSF) Maintenance Technician License. The Executive Director denied Mr. Mewis's application for cause. Mr. Mewis has requested a formal hearing on the Executive Director's decision. During the review of Mr. Mewis's application, the Executive Director became aware that Mr. Mewis received a State-Jail Felony in 2005, a State-Jail Felony in 2006, a 2nd-Degree Felony in 2021, a Class-B Misdemeanor in 2015, a 3rd-Degree Felony in 2016, and two Class-B Misdemeanors in 2018. The Executive Director denied Mr. Mewis's application because he has been convicted of offenses that directly relate to the license as referenced in Texas Occupations Code (TOC) §§ 53.021(a)(1), 53.022, and 53.023.

CONTESTED CASE HEARING.

The State Office of Administrative Hearings (SOAH) will conduct a preliminary hearing via Zoom videoconference. A Zoom meeting is a secure, free meeting held over the internet that allows video, audio, or audio/video conferencing.

The purpose of a preliminary hearing is to establish jurisdiction, name the parties, establish a procedural schedule for the remainder of the proceeding, provide an opportunity for settlement discussions, and address other matters as determined by the administrative law judge. The preliminary hearing will be held unless all timely hearing requests are withdrawn or the parties agree to waive the preliminary hearing.

The evidentiary phase of the contested case hearing, to be held at a later date, will be a legal proceeding similar to a civil trial in state district court to determine whether Mr. Mewis should be issued an OSSF Maintenance Provider License. Unless agreed to by all parties in attendance at the preliminary hearing, an evidentiary hearing will not be held on the date of this preliminary hearing. If Mr. Mewis fails to appear at the preliminary hearing or evidentiary hearing, the Executive Director will request that the hearing be canceled, and that appeal of the Executive Director's decision be dismissed.

Legal Authority: Texas Water Code Chapters 5 and 37; Texas Occupations Code Chapter 53; Texas Government Code, Chapter 2001; 30 Texas Administrative Code (TAC) Chapter 30, and the procedural rules of the TCEQ and SOAH, including 30 TAC Chapters 70 and 80 and 1 TAC Chapter 155.
