### PODCAST, from P. 1A

Sanchez, Jesus Rodriguez, and Casey Hagaman along with juniors Audrina Scott and Luis Ramirez and sophomore Randy Rangel. All six are on the school's yearbook staff, but they've begun a new endeavor, and are ready to shine a light on everything happening at AP High School.

"I think it's cool how everybody likes it and enjoys it, and getting people together to ask their perspective is really cool," Scott said. "A lot of us focus on our own (perspective) and don't really see outside that, so that's been a really awesome thing."

The podcast began as little more than an inkling as Scott said she used to go around interviewing and recording people to write about on her own personal vlog. However, she said it soon began to take on new life.

"I think we knew that we wanted it to become something bigger outside of just me vlogging, because we all liked the idea and knew we wanted to do it and bring it to a bigger audience," Scott said.

Fast forward a few months and all students involved say that creating the podcast has become one of the more exciting things to do. The first episode consisted of interviewing district and school administrators, but they have episodes lined up to interview and chat with their fellow students on a variety of topics.

#### Fun and fruitful

"My favorite part is asking students if they want to be on the podcast and if they want to talk," Sanchez said. "Honestly, before our first episode came out, nobody really knew about it. After it came out, the kids were really excited and they wanted to be on it."

Ramirez echoed the same type of sentiment, adding that it has become an intriguing endeavor to see different sides of their classmates.

"To see them want to join in on this activity and see them want to do more than stare at a screen, I think it's really cool," he said.

Added Rangel: "It's really cool the way they want to be involved."

Between setting up interviews, conducting the interviews, and editing the podcast, the students say they spend at least 10 hours per week working on the podcast. And that is on top of their typical schoolwork or any other extracurricular activities which they may be involved in.

But whether it's Rodriguez and Sanchez spending time editing the interviews to put out, or Hagaman and others setting up interviews, the students say the podcast has been a joy to undertake. The Panthers' Perspective Podcast is live on set with raw and uncut interviews.

"I really love the process of setting it up and going through the interviews - it's different, and it's fun to learn," Hagaman said.

The reward is even greater for podcast sponsor and AP High School teacher Elizabeth Worley, who oversees the podcast. Panthers' Perspective is completely student-led – an aspect that sets it apart from other productions around the Coastal Bend.

"Each student really does have a role in this, and from my standpoint it's really fun to watch their growth in this whole process; plus the excitement I've seen them take on and the student body as well," Worley said.

Ultimately, the students believe there is much more to Aransas Pass and its high school than meets the eye. And that's what they are aiming to bring out

"I feel like a lot of people see AP as a dull place," Scott said. "But when you're inside and seeing how everybody is together, it brings out what AP really is."

"It's very important for us all to participate in full scale collaborative exercises like this so that we can all be ready to respond for any type of emergency that might occur, and so that we can work together seamlessly when that happens," Savage director of public affairs Jeff Hymas said. "It's important for us to train and be ready for whatever might occur."

And when the Port of Corpus Christi brought the idea to GCGV through its planning committee and proposed the joint full-scale exercise, Hale called the decision a no-brainer for the company.

After all, he said they want to be good stewards of their environment. And that includes being part of any solution they believe will be for the greater benefit of their community and those who live in it.

"We're excited to bring those teams together," Hale said. "We want to be better, at all times, and every time we do this we've come away stronger than we were previously."

months, officials have said, is to give community members all around San Patricio and Nueces counties an opportunity to review and comment on the Coastal Bend Community Air Action Plan (CB-CAAP) project objectives.

Officials said those objectives originated from specialists and volunteers from various sectors crucial to air quality that include environment, transportation, tourism and recreation, small business, industry, construction and agriculture, port operations, academia, and public health. The meeting was not originally on the schedule, according to CBAQP executive director Sharon Bailey Murphy. But Murphy said the organization believed in giving the community one more chance before the plan is finalized.

Over the last several months, the CBAQP has hosted community meetings in Portland, Sinton, and Aransas Pass, and Nueces County. As the organization prepares to finalize its plan, Murphy said the process has been trying but rewarding.

"The opportunity to connect with the community and have their voices heard (has been amazing), to show them that we all do care and show them that it's not one-sided - we all contribute to the impacts to the air, and we're all a part of the solution," she said.

Now that the community meetings have ended, Murphy said the CBAQP tentatively plans to post the finalized and approved plan based on community input on its website for the community to see. Tentatively, she said the plan will be posted by December 2024, with implementation slated to hopefully begin in 2025.

Ultimately, with the soon-to-beimplemented plan and input from the community, she believes the Coastal Bend is headed in the right direction.

"To see the community come together to say 'We're going to come together and stick this out' (has been great)," she said. "Here's to the next 30 years."

"You know what, I'm going to back out of this, this is not necessary.... I'm submitting my resignation, effective immediately. You've got enough lawyers in the room," he said.

**Immediately** preceding his resignation, disputes arose regarding the resignation of previous city attorney Thomas Gwosdz and how it came to pass.

"I know you're a good

information

attorney, I know you used to be a judge. But the way that you were brought in was not right," council member Randy Haskins said. "They should never have fired or run off our city attorney who was trying to help this council and help this city; who was trying to do something for this city...."

Several minutes of heated discussion followed that statement, with Valdez initially chiming in on the discussion.

"I don't know what item this is on the agenda. Comments are one thing, but discussion is another. What you're having is a discussion," Valdez said regarding the conversation as it pertained to the previous city attorney.

And a few minutes later, it appeared Valdez had had enough. He submitted his public notice of resignation, which was effective immediately.

Aransas Pass City Council's next meeting is set for Nov. 4. The city can conduct meetings without an interim or permanent attorney. However, per state law, the council cannot go into executive session until another is appointed to the position.

This is the third resignation this month from the city, with Valdez's resignation adding to Gwosdz and city manager Gary Edwards, who resigned earlier in October.

"I appreciate your consideration, I really do. I wanted to come here and help you, and I really want to help you. But I can see it's going to be impossible," Valdez said. ".... And with that, I'll take my leave."

This notice has been revised to update the technical contact to Mr. Craig Kondoff.

# APPLICATION.

Corpus Christi Liquefaction, LLC, 700 Milam Street, Suite 1900, Houston, TX 77002-2835, has applied to the Texas Commission on Environmental Quality (TCEQ) for an amendment to State Air Quality Permit 139479 and modification to Prevention of Significant Deterioration (PSD) Air Quality Permit PSDTX1496M1, which would authorize modification to the Corpus Christi Liquefaction Stage 3 located at 622 Highway 35, Gregory, San Patricio County, Texas 78359. This application was processed in an expedited manner, as allowed by the commission's rules in 30 Texas Administrative Code, Chapter 101, Subchapter J. The existing facility will emit the following air contaminants in a significant amount: carbon monoxide, nitrogen oxides, organic compounds, and particulate matter including particulate matter with diameters of 10 microns or less and 2.5 microns or less. In addition, the facility will emit the following air contaminants: sulfur dioxide, hazardous air pollutants and hydrogen sulfide.

A full PSD increment analysis was not required because the predicted impacts of all pollutants subject to PSD increment review were below the significant impact level for each pollutant.

This application was submitted to the TCEQ on March 30, 2023. The executive director has determined that the emissions of air contaminants from the existing facility which are subject to PSD review will not violate any state or federal air quality regulations and will not have any significant adverse impact on soils, vegetation, or visibility. All air contaminants have been evaluated, and "best available control technology" will be used for the control of these contaminants.

The executive director has completed the technical review of the application and prepared a draft permit which, if approved, would establish the conditions under which the facility must operate. The permit application, executive director's preliminary decision, draft permit, and the executive director's preliminary determination summary and executive director's air quality analysis, will be available for viewing and copying at the TCEQ central office, the TCEQ Corpus Christi regional office, and at the Bell Whittington Library, 2400 Memorial Parkway, Portland, San Patricio County, Texas. The facility's compliance file, if any exists, is available for public review at the TCEQ Corpus Christi Regional Office, 500 North Shoreline Boulevard, Suite 500, Corpus Christi, Texas.

# DIRECT REFERRAL.

The Notice of Application and Preliminary Decision was published in English on May 16, 2024, and in Spanish on May 15, 2024. A Public Meeting was held on June 20, 2024. On July 25, 2024, the Applicant filed a request for direct referral to the State Office of Administrative Hearings (SOAH). Therefore, the chief clerk has

referred this application directly to SOAH for a hearing on whether the application complies with all applicable statutory and regulatory requirements.

#### CONTESTED CASE HEARING.

The State Office of Administrative Hearings (SOAH) will conduct a preliminary hearing via Zoom videoconference. A Zoom meeting is a secure, free meeting held over the internet that allows video, audio, or audio/video conferencing.

**SOLICITUD.** Corpus Christi Liquefaction, LLC, 700 Milam Street, Suite 1900, Houston, TX 77002 - 2835, ha solicitado a la Comisión de Calidad Ambiental de Texas (TCEQ) una enmienda al Permiso Estatal de Calidad del Aire 139479 y una modificación al Permiso de Calidad del Aire PSD (Prevention of Significant Deterioration) PSDTX1496M1, que autorizaría la modificación de la Corpus Christi Liquefaction Stage 3 ubicada en 622 Hwy 35, Gregory, Condado de San Patricio, Texas 78359. Esta solicitud se tramitó de forma acelerada, tal como permiten las normas de la comisión en el 30 Texas Administrative Code, Chapter 101, Subchapter J. La instalación existente emitirá los siguientes contaminantes atmosféricos en una cantidad significativa: monóxido de carbono, óxidos de nitrógeno, compuestos orgánicos, partículas, incluidas las partículas con diámetros de 10 micras o menos y de 2,5 micras o menos. Además, la instalación emitirá los siguientes contaminantes atmosféricos: dióxido de azufre, contaminantes atmosféricos peligrosos y sulfuro de hidrógeno.

No fue necesario realizar un análisis completo del incremento PSD porque los impactos previstos de todos los contaminantes sujetos a la revisión del incremento PSD estaban por debajo del nivel de impacto significativo para cada contaminante.

Esta solicitud se presentó a la TCEQ el 30 de marzo de 2023. El director ejecutivo ha determinado que las emisiones de contaminantes atmosféricos de la instalación existente que están sujetas a la revisión PSD no violarán ninguna normativa estatal o federal de calidad del aire y no tendrán ningún impacto adverso significativo en los suelos, la vegetación o la visibilidad. Se han evaluado todos los contaminantes atmosféricos y se utilizará la "mejor tecnología de control disponible" para el control de dichos contaminantes.

El director ejecutivo ha finalizado la revisión técnica de la solicitud y ha preparado un proyecto de permiso que, en caso de ser aprobado, establecería las condiciones en las que debe operar la instalación. El director ejecutivo ha tomado la decisión preliminar de expedir el permiso porque cumple todas las normas y reglamentos. La solicitud de permiso, la decisión preliminar del director ejecutivo y el borrador del permiso estarán disponibles para ver y copiar en la Oficina Central de la TCEQ, la Oficina Regional de Corpus Christi de la TCEQ, y en la Biblioteca Bell Whittington, 2400 Memorial Parkway, Portland, Condado de San Patricio, Texas. El expediente de cumplimiento de la instalación, si existe, está disponible para revisión pública en la Oficina Regional de Corpus Christi de la TCEQ, 500 North Shoreline Boulevard, Suite 500, Corpus Christi, Texas.


