Robert and Adrian,

I have a few clarifying questions:

- (1) Given the information I have referenced about the context, scope and scale of TCEQ's response to Hurricane Harvey, is it false or misleading to claim that TCEQ was "missing in action"?
- (2) Are you aware that Mr. Coleman's revised article now hyperlinks to an editorial containing a false statement that is effectively the same as the one Mr. Coleman removed from his original article?
 - Specifically, Mr. Coleman links to a May 25, 2018, Houston Chronicle editorial about the extent of pollution during Harvey and its aftermath. Concerning TCEQ's monitoring activities, the editorial asserts: "We only have the information the polluters themselves reported" As you gentlemen know, TCEQ posted air quality monitoring information (i.e., data and reports from its network of stationary monitors and other sources) to its website in near real time.
- (3) Did Mr. Coleman's efforts to ensure the factual accuracy of his assertion about TCEQ's air quality measurements during Harvey include (a) inquiring of any TCEQ employee or (b) searching the internet for information that TCEQ may have posted about air quality monitoring?
