Introduction

The review assessed whether the initial reasons for adopting the rules continue to exist, and the commission has determined that those reasons exist. The rules for control of volatile organic compounds (VOC) emissions in Chapter 115 were specifically developed to meet the federal Clean Air Act requirements for attainment and maintenance of the National Ambient Air Quality Standards (NAAQS) for ozone set by the United States Environmental Protection Agency (EPA

Summary:

The rulemaking requires the owner or operator of adhesive application processes in Wise County to comply with the same rules that currently apply in the other nine DFW counties.

The rulemaking also clarifies which adhesives being used for miscellaneous metal or plastic parts coating are exempt from this division. The rulemaking also clarifies a portion of the coating application system requirement.

The rulemaking is necessary to satisfy federal reasonably available control technology (RACT) requirements for Wise County as a result of the DFW nonattainment area's expansion under the 2008 eight-hour ozone NAAQS. This rulemaking is part of the DFW 2008 Eight-Hour Ozone Nonattainment Area Attainment Demonstration SIP Revision (2013-015-SIP-NR) (06/03/2015).

Summary:

The rulemaking establishes adhesive and adhesive primer volatile organic compounds (VOC) limits, work practices, testing procedures to demonstrate compliance with the VOC limits, monitoring and recordkeeping requirements, and exemptions for certain adhesive and adhesive primer processes that when combined equal to at least 3.0 tons per year of VOC emissions.

These rules apply only to manufacturing operations where adhesives or adhesive primers are used during certain application processes specified in the rule. The rule requirements area based on the recommendations in the EPA's 2008 *Control Techniques Guidelines for Miscellaneous Industrial Adhesives* document (EPA 453/R-08-005).

This rulemaking is necessary to satisfy federal RACT requirements.
