## SIP Revision: Beaumont-Port Arthur, Agreed Orders, December 15, 2004

On December 15, 2004, the commission adopted a State Implementation Plan (SIP) revision to incorporate eight site-specific agreed orders for six companies in the Beaumont-Port Arthur (BPA) area.

### Summary of the SIP Revision

**Adoption Date:** 12/15/2004

**EPA Approval Date:** 04/12/2005 (70 FR 18995)

**Key Changes:** This SIP revision incorporates certain voluntary emissions reductions, air monitoring improvements, and other actions which six companies in the BPA took in support of the area's ozone attainment demonstration. These actions were the result of negotiations between the state, the companies, environmental organizations, and the United States Environmental Protection Agency (EPA). The commitments were made enforceable through agreed orders that were incorporated into this SIP revision. No specific credit was taken for the actions, which included the voluntary shutdown of several units, equipment modifications, voluntary permits, installation of pollution control systems, improved recordkeeping, and enhanced monitoring.
