SIP Revision: Dallas-Fort Worth (DFW) 1997 Eight-Hour Ozone Attainment Demonstration (AD), December 7, 2011

On December 7, 2011, the Texas Commission on Environmental Quality (TCEQ) adopted an AD State Implementation Plan (SIP) revision for the DFW serious nonattainment area under the 1997 eight-hour ozone standard.

Summary of the SIP Revision

EPA Action: Disapproval and Clean Data Determination 09/01/2015 (80 FR 52630)

Background: On December 20, 2010, the DFW area was reclassified from a moderate to a serious nonattainment area for the 1997 eight-hour ozone NAAQS (75 FR 79302). The United States Environmental Protection Agency (EPA) set January 19, 2012 as the deadline for Texas to submit AD and reasonable further progress (RFP) SIP revisions to address the serious ozone nonattainment area requirements of the 1990 Federal Clean Air Act (FCAA) Amendments. Concurrent with this SIP revision, the commission adopted rule revisions to the Chapter 115 volatile organic compounds (VOC) reasonably available control technology (RACT) Rule and the Chapter 115 VOC Storage Rule.

Key Changes:

This SIP revision included:

- Photochemical modeling and weight of evidence analysis to demonstrate attainment by June 15, 2013;
- A RACT analysis;
- A reasonably available control measures (RACM) analysis;
- A motor vehicle emissions budget (MVEB) for 2012, and
- A contingency plan.
