# SIP Revision: Post-1999 Rate of Progress (ROP) and Attainment Demonstration for the Houston-Galveston (HGA) Ozone Nonattainment Area, December 6, 2000

Revisions to the Post 1999 ROP and AD State Implementation Plan (SIP) for the HGA nonattainment area for the one-hour ozone National Ambient Air Quality Standards (NAAQS).

# **Summary of the SIP Revision**

**Adoption Date:** 12/06/2000 **Proposal Date:** 08/09/2000

**EPA Actions:** Approved on 11/14/2001: attainment and reasonable further progress (RFP) demonstrations (66 FR 57160<sup>©</sup>); vehicle miles traveled (VMT) offset demonstration (66 FR 57247<sup>©</sup>); nitrogen oxides (NO<sub>X</sub>) rules (66 FR 57230<sup>©</sup>); Mass Emissions Cap and Trade (MECT) (66 FR 57252<sup>©</sup>); Texas Low-Emission Diesel (TxLED) rules (66 FR 57196<sup>©</sup>); Ground Support Equipment (GSE) electrification rules and non-road large spark ignition standards (66 FR 57219<sup>©</sup>); lawn service operating and idling restrictions (66 FR 57223<sup>©</sup>); and inspection and maintenance (I/M) program (66 FR 57261<sup>©</sup>).

**Background:** The United States Environmental Protection Agency (EPA) indicated that the state needed to adopt the strategies modeled in the November 1999 SIP submittal, and then adopt sufficient measures to close the remaining gap in NO<sub>x</sub> emissions in order to have an approvable AD. On December 6, 2000, the commission adopted revisions to the ROP/AD SIP for the HGB one-hour ozone nonattainment area and the rules in 30 Texas Administrative Code (TAC) Chapters 101, 114, 115 and 117.

#### **Key Changes:**

- Photochemical modeling analyses;
- Post-1999 ROP plans for the milestone years 2002 and 2005, and for the attainment year 2007;

- Control measures and enforceable commitments to implement further measures in support of the HGB AD; and
- A commitment to perform and submit a mid-course review (MCR).
