Purpose: TCEQ has issued this Request for Information to gather sales price information for select on-road vehicles and non-road equipment to establish grant amounts for the upcoming Diesel Emissions Reduction Incentive (DERI) Program. Email the latest sales price of qualifying vehicles and equipment to TERPapply@tceq.texas.gov before the deadline to ensure that your vehicles or equipment are included for rebates.

Qualifying Vehicles and Equipment

Heavy-Duty On-Road Vehicles:

- Model year 2020 or newer; and
- Gross Vehicle Weight Rating (GVWR) of 8,501 lbs. or more (does not include a vehicle over 8,500 lbs. classified as a medium-duty passenger vehicle subject to the federal light-duty vehicle emission standards).

Qualifying Non-Road Equipment:

- Engine with a manufacture year 2020 or newer; and
- Engine rated at 25 horsepower (HP) or greater.

Instructions

Pricing information can be submitted through one or more of the following options: 1.) pricing lists, 2.) recent sales information, or 3.) by completing the attached form.

1. Pricing lists should include:
 - a. make, model, and year (for on-road vehicles), or engine manufacture year (for non-road equipment);
 - b. [GVWR-based Vehicle Class](#) (for on-road vehicles), or horsepower (for non-road equipment);
 - c. fuel types (*e.g., diesel; gasoline; compressed natural gas; liquified natural gas; liquified petroleum gas; electric; plug-in hybrid electric; hydrogen; bio-diesel; or bi-fuel*).
2. Recent sales information (January 2022 or newer) including invoices, public dealer advertising, dealer price lists, or other verifiable documentation. Recent sales information should include:
 - a. make, model, and year (for on-road vehicles), or engine manufacture year (for non-road equipment);
 - b. [GVWR-based Vehicle Class](#) (for on-road vehicles), or horsepower (for non-road equipment);
 - c. fuel types (*e.g., diesel; gasoline; compressed natural gas; liquified natural gas; liquified petroleum gas; electric; plug-in hybrid electric; hydrogen; bio-diesel; or bi-fuel*).
