- Began preliminary engineering and site plan work in preparation for construction of the solar PV facility

- The first three bullets above relate to Task 1. The contract with 1Energy must be in place for AE to meet Task 1 deliverables. The accomplishments described above are in accordance with City of Austin's procurement policies.

During Q4 2015 and regarding the adjacent solar PV facility, AE, through its PPA with PowerFin Partners, plans to continue preparatory work necessary in advance of site construction. Such work may include site plans, preliminary engineering analysis and design, site zoning, community outreach and permitting.
