- AE is reviewing final detailed design work for the Energy Storage System (ESS) under Task 1 with energy storage integrator, Doosan GridTech (Doosan).
- AE started civil work for the ESS inside the Kingsbery substation as part of the work to be completed under Task 4, and is on task to be completed prior to October 31, 2017.
- PowerFin Partners (PowerFin) obtained site plan permits from the City of Austin and initiated site clearing for the Community Solar facility under Task 5.

Section II: Problems/Solutions

Problem(s) Identified: Report anticipated or unanticipated problem(s) encountered and effect(s) on the progress of the project

a) The completion date for the Community Solar facility has been delayed due to several site plan reviews (total of 3 submissions) by Development Services Department. Delays were primarily related to transportation/sidewalk/roadway designs, and critical water quality zones (thriving invertebrate populations were found in runoff areas on the site, resulting in their designation as critical water quality zones which could not be developed upon). Additionally, PowerFin has identified a potential delay in lead-time for switchgear – just became aware of this in June. These items relate to Task 5 of the Grant Activities. Paragraph 2.5.2 of the TCEQ award states "PERFORMING PARTY will complete this task on or before August 31, 2017 unless an alternate date is approved by the TCEQ."

a) AE requests TCEQ approval to change the Task 5 deadline from August 31, 2017 to December 31, 2017.

Action(s) Conducted and Results: Describe the action(s) taken to resolve the problem(s) and effect(s) had

a) Redesign of internal roadways and panel locations); drainage and water quality protections (e.g. vegetative filter strip and rain garden engineering and approval took roughly 5 months of back and forth with reviewers and project engineers). Approval by Land Use & Planning Commissions and issuance of Conditional Use Permit June 2017.
