Project Summary (150 words or less): This project will install a vapor recovery unit (VRU) at NuStar Logistics, L.P. Southlake Terminal (NuStar or Sunoco) in Tarrant County. Hydrocarbon vapors from loading operations are currently controlled using a vapor combustion unit (VCU). The hydrocarbon vapors and supplemental natural gas are combusted with the combustion byproducts directly emitted into the air. This project will replace the VCU as the primary vapor control system with a VRU. This change will reduce emissions in two ways. First, the hydrocarbon vapors will be captured and placed back into product streams rather than being combusted. Second, supplemental natural gas will not be required for the VRU.


