 registration for operation in several states including Texas may be considered as proof of continuous registration
 and operation in Texas.

2. Third-Party Vehicle Certifications

- a. Registration. The vehicle has been registered in Texas for at least the two years immediately preceding the submission of this form.
- **b. Operation**. The vehicle has been operated at least 75% of the vehicle's total annual miles of operation in Texas for the two years immediately preceding the application signature date.
- **c. Condition.** The vehicle is currently in operating condition and has a remaining useful life of 2 or more years.
- **d. Qualifying Vehicle.** The vehicle will be replaced with a qualifying vehicle of the same weight classification and used in the same application or vocation.
