 registration and operation in Texas.

2. Third-Party Equipment Certifications

By signing below, the applicant and current owner of the vehicle or equipment certifies that the vehicle or equipment meets the following requirements.

a. Registration (On-road only). The vehicle has been continuously registered in Texas for at least the two years immediately preceding the application signature date.

b. Operation. The vehicle or equipment has been continuously operated in Texas for the two years immediately preceding the application signature date.

c. Condition. The vehicle or equipment is currently in operating condition and has a remaining useful life of 5 or more years.

d. Qualifying Vehicle or Equipment. The vehicle or equipment will be replaced with a qualifying vehicle of the same weight classification or piece of equipment of the same horsepower range and used in the same application or vocation.
