2. Third-Party Fleet Vehicle Certifications

By signing below, the applicant and current vehicle owner (if applicable) certifies that the vehicle meets the following requirements.

- **a. Registration.** The vehicle has been continuously registered in a county in the Clean Transportation Zone (CTZ) for at least the two years immediately preceding the submission of this form.
- **b. Operation**. The vehicle has been continuously operated at least 75% of the vehicle's total annual miles of operation in Texas for the two years immediately preceding the application signature date.
- c. Condition. The vehicle is currently in operating condition and has a remaining useful life of 2 or more years.
- **d. Qualifying Vehicle.** The vehicle will be replaced with a qualifying vehicle of the same weight classification and used in the same application or vocation.
