2. Third-Party Equipment Certifications

a. Operation. The equipment has been continuously operated in Texas for the two years immediately preceding the application signature date.
b. Condition. The equipment is currently in operating condition and has a remaining useful life of 5 or more years.
c. Qualifying Equipment. The equipment will be replaced with a qualifying piece of equipment of the same horsepower range and used in the same application or vocation.
