Subject: Domestic Municipal Industrial (DMI) Reserve and Distribution of Rio San Juan Water

Dear Water Right Holder:

Texas' storage in the Amistad/Falcon system is at historically low levels. Drought and the lack of deliveries from Mexico under the 1944 Water Treaty (Treaty) have resulted in very low inflows to the Amistad/Falcon system. As of November 16, 2024, Mexico has only delivered 427,914 acre-feet (AF) of water, which is 30% of the expected deliveries at this point in the five-year delivery cycle or a deficit of 996,249 AF. As a result of these low deliveries, the United States' share in the Amistad/Falcon system stood at 689,542 AF or 20.43 % of normal conservation capacity on November 16, 2024. The most recent Drought Outlook projects that current dry conditions will persist, and further drought development is likely over the next several months.

In accordance with Texas Water Code (TWC), [§11.3271](#) and Texas Commission on Environmental Quality's (TCEQ's) Rio Grande Watermaster rules in 30 Texas Administrative Code (TAC) [Chapter 303](#), the Rio Grande Watermaster is required to administer the water in the Amistad/Falcon system in accordance with adjudicated water rights and is responsible for enforcing water rights.

The International Boundary and Water Commission (IBWC) signed Minute 331 on November 7, 2024. Consistent with Resolution 8 of Minute 331, Mexico has offered to deliver water originating from the Rio San Juan for Treaty credit. This water will be accounted for through ownership transfers from Mexico to the United States at Anzalduas Dam, for a specified time period of use, and with a specified credit adjustment to account for the losses associated with conveyance of the water.

The delivery of water from the Rio San Juan can provide immediate benefit to Texas water right holders. However, TCEQ's current allocation system does not address the distribution of those deliveries, nor does the Texas Water Commission's August 6, 1981 "No Charge" Order provide for the distribution of such deliveries.

Based on the lack of prior water deliveries from Mexico and the extremely low storage in the Amistad/Falcon reservoir system, I am exercising my authority under [30 TAC §303.22 \(h\)](#) to distribute water delivered from the Rio San Juan in a manner which promotes beneficial use of this water, ensures that benefits to water right holders from these deliveries are distributed equitably throughout the system in accordance with the adjudicated water rights, and protects domestic, municipal, and industrial (DMI) use and the DMI reserve which supports that use.

The purpose of this letter is to inform you of anticipated deliveries of water from the Rio San Juan, provide information on how I will distribute those deliveries, and inform you of actions I am taking in the Amistad/Falcon system.

DMI Reserve and Distribution of Rio San Juan Water

DMI use.

DMI is the highest priority use in the Amistad/Falcon system; therefore, I will implement the following:

- A DMI reserve for Amistad Reservoir will be established and maintained at 55,000 AF. This new Amistad reserve is equal to approximately one year of the current DMI use between Amistad and Falcon Reservoirs. The 55,000 AF Amistad DMI reserve is a component part of the total Amistad/Falcon system DMI reserve – it is not a separate reserve.
- When inflows are adequate to fill dead storage and all reserves, I will use all or a portion of the remaining water to increase the total system DMI reserve to 280,000 AF. I expect this increase to occur incrementally and take several months if inflows remain low and DMI use does not decrease.

This increased Amistad/Falcon system DMI reserve is equal to approximately one year of the current DMI use in the Amistad/Falcon system. I will continue to monitor the DMI use in the system and will adjust the Amistad/Falcon system DMI in another manner or implement additional increases if inflows continue to decline or DMI use accelerates.

Please be advised that DMI use includes the losses associated with the transportation of DMI water once diverted from the mainstem of the Rio Grande only to the extent that the transportation loss is charged to a DMI account. Transportation losses charged to Class A and B accounts are not reflected in DMI use, and the DMI reserve is not structured to support these losses.


I have developed Operating Procedures for distributing Rio San Juan water which are attached at Appendix A. Appendix B summarizes the current offer of Rio San Juan water and its distribution and provides a list of the water rights receiving a distribution of Rio San Juan water and those that will receive an equitable benefit.

As stated in my April 15, 2024, letter, without significant reductions in demand through water conservation, critical water shortages can develop. I again urge water right holders to review measures that will reduce demand and conserve water, update those measures to reflect the seriousness of current conditions, and expedite implementation in an effort to avoid critical shortages.

The Rio Grande Watermaster Program will continue to closely monitor water supplies in the Amistad/Falcon system, drought conditions, and weather forecasts.

Attachment A: Operating Procedures for Distributing San Juan Water


1. Offers of Rio San Juan water will be distributed to Class A and B water rights below the confluence of the Rio San Juan and the Rio Grande which are active on the date the offer is accepted, in accordance with adjudicated water rights.
 - a. Each Class A and B water right holder will have a San Juan Temporary Permit established and the distributed offer will be placed into that permit. San Juan Temporary Permits will be administered in the same way that other temporary permits in the Amistad/Falcon system are administered, with the following exceptions:
 - i. San Juan Temporary Permits must be used first, before any other account is used.
 - ii. San Juan Temporary Permits will expire either at the end of the period of use specified in the offer, once all Rio San Juan water has been delivered, and/or when the account has a zero balance, whichever occurs first.
 - iii. DMI adjustments can be made. DMI adjustment charges and credits will be made to Amistad/Falcon system accounts. These adjustments ensure that DMI water is accounted for in the Amistad/Falcon system where the reserve for these accounts is located.
 - iv. If at any time Mexico discontinues the delivery of Rio San Juan water, San Juan Temporary Permits will be suspended until deliveries resume.
 - v. Contractual sales of the water distributed to San Juan Temporary permits are prohibited.
 - b. International Boundary and Water Commission (IBWC) Operational Procedures specify when demand for Rio San Juan water must be communicated. The specific impact of these requirements varies by water right and will be communicated to the impacted water right holders.
2. An operating reserve for Rio San Juan water will be established prior to distributing Rio San Juan water to Rio San Juan Temporary Permits.
3. After all water from the Rio San Juan is delivered and all reserves are fulfilled, I will distribute an equitable benefit to Class A and B water rights above the confluence of the Rio San Juan and Rio Grande that are active on the date the offer is accepted, in accordance with water rights.

Each Class A and B water right holder will have an Equitable Benefit Temporary Permit established and their equitable benefit placed into that permit. Equitable Benefit Temporary Permits will be administered in the same way that other temporary permits in the Amistad/Falcon system are administered, with the following exceptions:

- a. Equitable Benefit Temporary Permits must be used first, before any other account is used.
- b. Equitable Benefit Temporary Permits expire one year from the date they are established or when the usable balance in the water account equals zero.
- c. Contractual sales of the water distributed to Equitable Benefit Temporary permits are prohibited.

These procedures may be adjusted if IBWC Operational Procedures are adjusted and as there is a need to clarify the procedures.
