Item Number 11 **Description** Has the generator notified the appropriate commission regional office of any transporter or authorized scrap tire facility that fails to complete the manifest, alters the generator portion of the manifest, or fails to return the manifest within three months after the off-site transportation of the used or scrap tires or tire pieces?

Item Number 12 **Description** Does the generator maintain original manifests or other documentation used to support activities related to the accumulation, and shipment of used or scrap tires or tire pieces for three years and are they available to the executive director upon request?

Item Number 13 **Description** Has the generator ensured that changes made to an original record remained legible and readable and has the person making the change placed his or her initials on the document with the date of the change?

Item Number 14 **Description** If there has been a change in documentation, has written justification been prepared and maintained with the original record for a period of three years and made available to the executive director upon request?
