- Please remember that even in an emergency, water systems cannot make changes to PWS facilities without plan approval
- We can issue emergency authorizations

- The email should clearly explain the situation and tell us what changes you are proposing to address the emergency

Submit Public Water System Plans for Review

This page contains information about submitting your plans to TCEQ to be reviewed before construction begins.

No person may begin construction of a public drinking water supply system until the TCEQ determines that the system is financially stable and technically sound, and can supply adequate quantities of safe drinking water. Public Water Systems must notify the TCEQ about any proposed new system or significant changes to existing systems.

The Plan Review Team under the Plan and Technical Review Section of the TCEQ Water Supply Division conducts the reviews. The reviews are based on the requirements in the **Rules and Regulations for Public Water Systems** 2 in the Texas Administrative Code, Title 30, Chapter 290, Subchapter D.

EMERGENCY TEMPORARY WATER HAULERS

This guidance document describes the process that the Texas Commission on Environmental Quality (TCEQ) will use to review temporary operations to provide drinking water for sanitary purposes to communities or businesses experiencing low pressure or water outage only. The TCEQ will consider temporary approval of water hauling with food grade equipment previously used for hauling other consumable beverages such as juice or milk.

Please provide the following information about your proposed temporary system:

- Water hauling truck/tank:
 - Types of liquids previously hauled by the truck;
 - Capacity of tank;
 - o Date of last disinfection of tank, if known; and,
 - Bacteriological test results following the last disinfection.
- Short description of proposed temporary system, including:
 - specific information about the number of individuals to be served,
 - the approved water source,
 - facilities used to transfer the water including pumps and hoses,
 - the license number for the truck and trailer (if applicable), and
