## Occupational Licensing (OL) Updates: Jaya Zyman, Tamara Calhoun

Teresa Etheridge presented the licensing statistics for 4th quarter of FY24 reviewed.

#### **Revision of the Wastewater B Exam:**

Revisions to the Wastewater B exam were recently implemented. We appreciate WUOLAC members who helped with these revisions. Historically, when an exam is revised, we see a decline in the pass rate.

#### **Resiliency update:**

Resiliency overview course: Individuals **cannot** repeat the overview course for resiliency credit, but if taken more than once, a person will receive continuing education credit hours. There are a lot of resiliency courses being offered in the state,

be sure the training provider states their training is approved for TCEQ resiliency credit, or is listed on the resiliency portion of the TCEQ <u>training website</u>.

#### **SETH Pilot Program**

Fourteen students completed the training, 13 took the exam. Of the 13, 7 of those were for a provisional license since some have not graduated high school yet. Six of them were for the regular D (recent graduates). Out of the 7 provisional, 4 passed. Out of the 6 regular D, 3 passed.

TAWWA responded to student's feedback to improve the course. For example, they provided a printout of the PowerPoint slides so the students would not have to take extensive notes in real time.

- Our feedback to TAWWA was largely based on student's feedback. TAWWA will adopt some of our if not all our suggestions moving forward.
- Over 300 Independent School Districts have expressed interest in participating in this program.
- Karen Menard Plan in place to have volunteers working for the program that will help the SME's stay in contact with ISD's regarding job availability for those students who pass and want to continue in the water field.
- Seeking WUOLAC member's input on upcoming retirees and those who will be joining the field. Any local information that could be shared to help in forecasting the rate of jobs being filled as well as those leaving or retiring.

#### DAM 13 TCEQ resiliency

Initial review is underway. This training is for an 8-hour day to be counted for resiliency overview & continuing education. TCEQ can schedule a date and time to come to facilities for this in-person training. We will investigate the possibility of recording this training in the future to be offered as self-paced training.

#### **Water D Exam Revisions**

We need to include resiliency questions now that resiliency is required. We are seeking WUOLAC volunteers to create a bank of resiliency questions we can use for exam.

#### **Increase in Fingerprinting subscriptions**

In the first quarter we had about 426 people subscribing, and now the number is up to 800. We have doubled our subscriptions.

#### Fingerprinting subscriptions feedback:

- Not having to resubmit their data repeatedly.
- Not having to worry about their criminal history at time of license renewal.
- More efficient and saving a lot of time.
