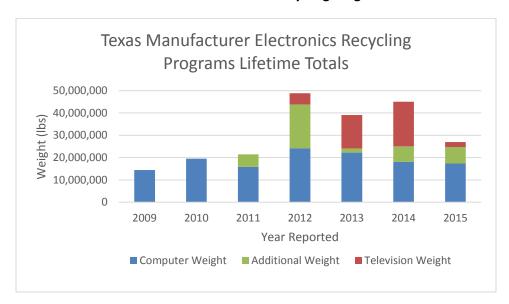

### **Results from Manufacturers' Annual Reports**

The Texas Recycles Computers and Texas Recycles TVs programs have been active for several years now and together have resulted in 173,791,682\* lbs. of computers and televisions being collected, with 164,420,809 lbs. of this being recycled and 133,454 lbs. being reused. Computer manufacturers also collected an additional 41,670,009 lbs. of additional weight over the lifetime of the program, bringing the total weight of electronics collected to 215,461,691\* lbs. For the 2015 calendar year, the programs collected a total of 27,003,181\* lbs.; with 17,347,738 lbs. of computers, 7,428,180 lbs. of additional electronic equipment, and 2,227,263\* lbs. of televisions. See *Chart 1* below for the weights collected since the creation of both programs.

#### **Texas Recycles Computers Program**

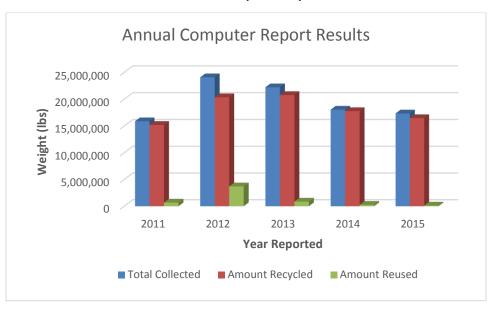
In reporting year 2015, the total combined weight of computer equipment collected was 17,347,738 lbs. The total amount recycled was 16,475,708 lbs. and the total amount reused was 127,614 lbs. Comparatively, the total weight of computer equipment collected in 2014 was 18,055,627 pounds. Of that collected weight, 17,789,409 pounds were recycled and 266,025 pounds were reused.

In addition to recycling covered computer equipment, many computer manufacturers also voluntarily collect televisions and other electronics for recycling. The TCEQ allows computer manufacturers to report other electronics collected, not just the computer equipment covered under the program. For 2015, manufacturers reported collecting 7,428,180 lbs. of additional non-covered electronics. The number was higher than 2014 voluntary collection amounts of 6,989,462 pounds. The voluntarily

reported numbers that included televisions reported under the Texas Recycles TVs program were excluded.

Historical data for the most current five years of reporting is reflected in *Chart 2* below.

Texans have many opportunities to recycle their computer equipment and other electronics outside of the Texas Recycles Computers Program. Collection events coordinated by municipalities, local nonprofit groups, private recyclers, and community-oriented businesses are additional ways Texans can recycle their computers. Since some of the recyclers do not report to the TCEQ, the agency's reported number does not fully represent recycling activity in Texas.

As in previous years, some reports this year listed zero pounds of computer equipment collected, reused, or recycled. A common reason for a manufacturer to report collecting no computer equipment is because the manufacturer is a small business with a clientele limited to surrounding homeowners who do not often buy new equipment. Additionally, in situations where manufacturers' customers are primarily businesses, and personal equipment is rarely sold, little or no personal or home business computer equipment was returned for recycling or reuse. With the recent surge in manufacturers entering the tablet market, relatively new manufacturers' products have not reached their end of useful life and been returned for recycling.

As discussed in previous years, with the rapid advancement of technology, electronics continue to become lighter and more compact. We have proposed that this trend could lead to manufacturers reporting lower total weight of materials collected. A report published in July 2011 on behalf of the

Consumer Electronics Association (CEA) detailed this manufacturing trend between 2004 and 2010 from cathode ray tubes (CRT) to lighter flat panel technology for televisions and computer monitors.<sup>1</sup>

Appendix 1 lists amounts reported by each manufacturer for the 2015 calendar year. Some numbers reported by manufacturers as recycled or reused may have been collected in a previous year.

#### **Texas Recycles TVs Program**

2014 was the second year that TV manufacturers were required to establish a recycling program and the first year that individual manufacturers were required to collect their market share allocation. Participating manufacturers reported collecting 20,033,910 pounds of TVs. The TCEQ calculated the state recycling rate and market share for manufacturers participating individually. The state recycling rate was determined to be 9.5 percent. The market share for each affected manufacturer was determined by multiplying a manufacturer's reported weight in sales for calendar year 2013 by the recycling rate. For manufacturers that reported their sales weight nationally, census data was used to calculate the percentage of their sales for the state of Texas. Manufacturers were provided their market share; and those market shares are reported in *Appendix 2*, *Table 1*. Manufacturers were required to collect at least this amount in 2015. Several manufacturers failed to meet their allocated market share, citing issues with their recycler or lack of consumer participation in the company recycling takeback plan. After a period of compliance assistance these manufacturers either changed their recycler, or decided to join an active recycling leadership program to ensure their future standing in the program.

As part of the program, TV manufacturers that participated in the program as individuals collected 1,844,264 pounds of TVs in 2014. Of that, 1,841,802 pounds were recycled and 2,462 pounds were reused.

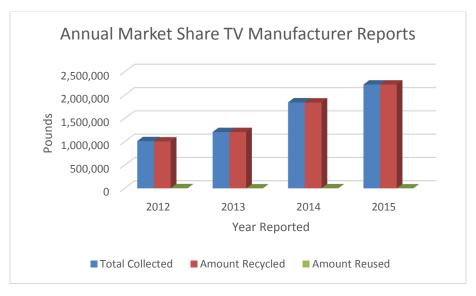
At the time that this report was completed the TCEQ had received reports from the majority of manufacturers, but a small number failed to report as can be seen in *Appendix 2, Table 2*. In 2016, 24 manufacturers representing 38 brands submitted complete registrations by the time this report was submitted. An additional two manufacturers representing four brands satisfied their program requirements by participating through the Texas Recycles Computers program.

The TCEQ calculated the state recycling rate and market share for manufacturers participating individually. The state recycling rate was determined to be 6.8%, a reduction from the previous year due in part to an increase in weight sold by manufacturers. Manufacturers were provided their market share by Dec. 1, 2015. The individual market shares are reported in *Appendix 2, Table 2*. Manufacturers will be required to collect at least this much in 2016.

The weight of TVs reported as having been collected in 2015 by manufacturers that participated in the program as individuals was 2,227,263. Of that collected weight, 2,227,263 pounds was recycled and 0 pounds was reused.

Chart 3 shows the weights reported as being collected by manufacturers that chose to participate under the market share options since the first reporting year in 2012.

In 2014, there were two recycling leadership programs. Fourteen manufacturers participated with the MRM Manufacturer RLP. Four manufacturers participated in the MITS RLP. The MITS RLP failed to meet the RLP requirements and ended after its first year of operation. January 2015 was the first time that RLPs were required to submit their Collection Reports.

The MRM Manufacturer RLP submitted their first required biennial report at the beginning of 2015 with recycling information provided for the two years they had been in operation, 2013 and 2014. The manufacturers participating in the MRM Manufacturer RLP recycled 13,741,019 pounds in 2013 and 18,189,646 pounds in 2014. This information is shown graphically in *Chart 4*.

Appendix 2 lists data reported by each manufacturer in the 2015 and 2016 reports. The reports reflect amounts sold and collected in calendar year 2014 with *Table 1* and 2015 with *Table 2*. The tables also indicates how the manufacturer chose to participate in the program in 2015 and 2016. This data was submitted by manufacturers through February 2016. Due to the short duration between the manufacturers report deadline of January 31 and the Legislative Report deadline of March 1, limited quality assurance and analysis of the 2016 data has been completed.

### **Registered TV Recyclers**

Beginning January 31, 2014, television (TV) recyclers were required to report the total weight or volume of TVs received, recycled, and disposed of in the preceding calendar year (CY) on an annual basis. In CY 2013 (January 1, 2013- December 31, 2013), Texas TV recyclers received approximately 22 million pounds, recycled 21 million pounds, and disposed of 4,300 pounds of covered television equipment.

In CY 2014 (January 1, 2014- December 31, 2014), approximately 24.3 million pounds were received, 23 million pounds were recycled, and zero pounds were disposed of, as reported by 15 active TV recyclers.
