A person who is engaged in the business of recycling covered TV equipment in accordance with Title 30, Texas Administrative Code §328.181 (relating to Recycler Responsibilities), must:

1. Annually report the total weight or volume of TVs received, recycled, and disposed of in the preceding calendar year.
2. Annually renew their registration and compliance certification. They will be able to meet this requirement with their annual report submittal and an updated [Notice of Intent \(NOI\) to Operate a Recycling Facility Under 30 TAC Sections 328.4 and 328.5 \(texas.gov\)](#) will **not** be required.

**The report for calendar year 2022 (January 1, 2022 through December 31, 2022) is due to TCEQ no later than January 31, 2023.**
