

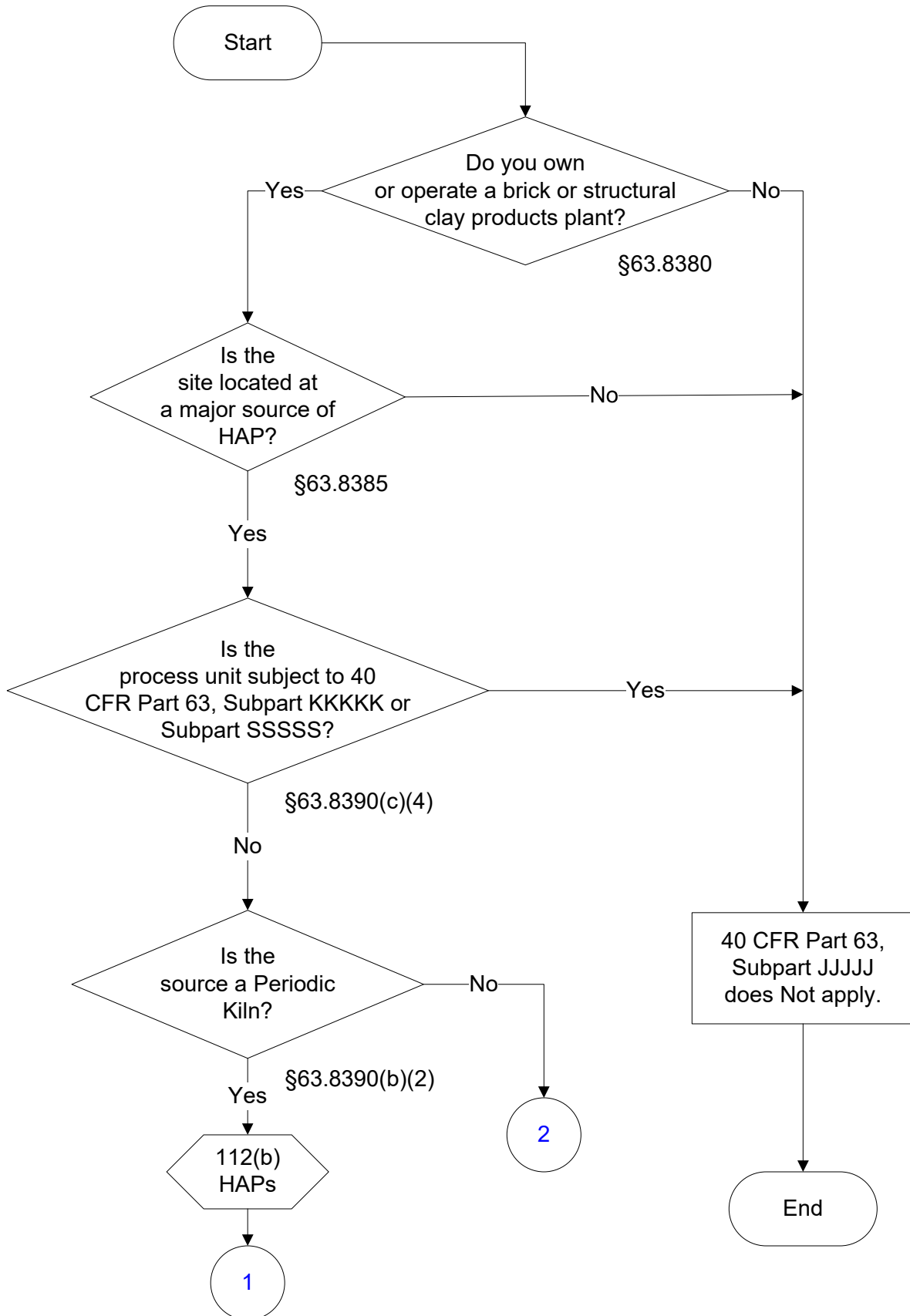


Below is a flowchart describing 40 CFR Part 63, Subpart JJJJJ.

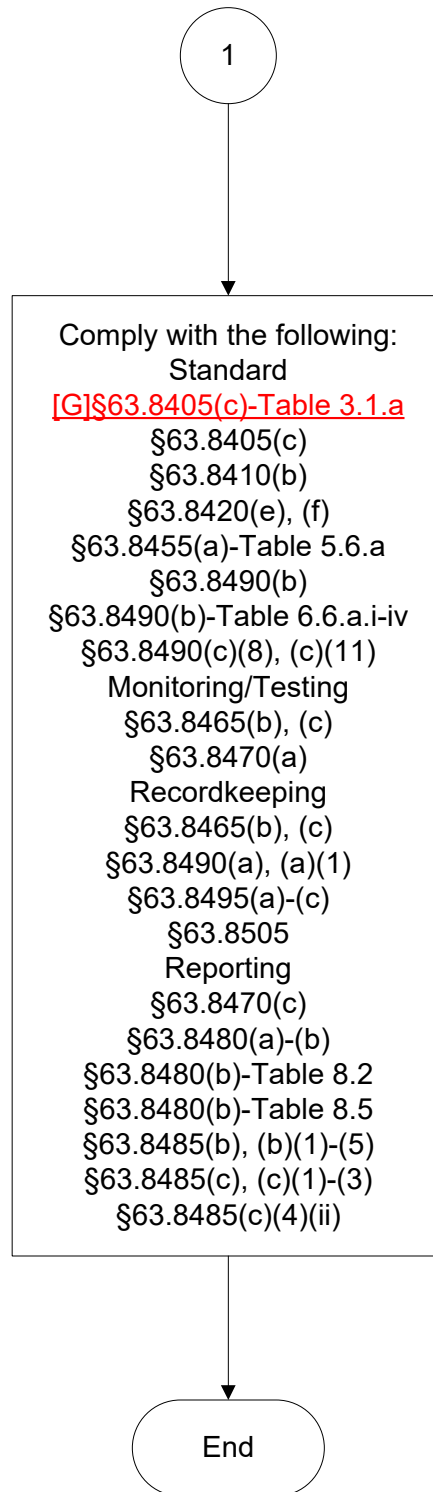
