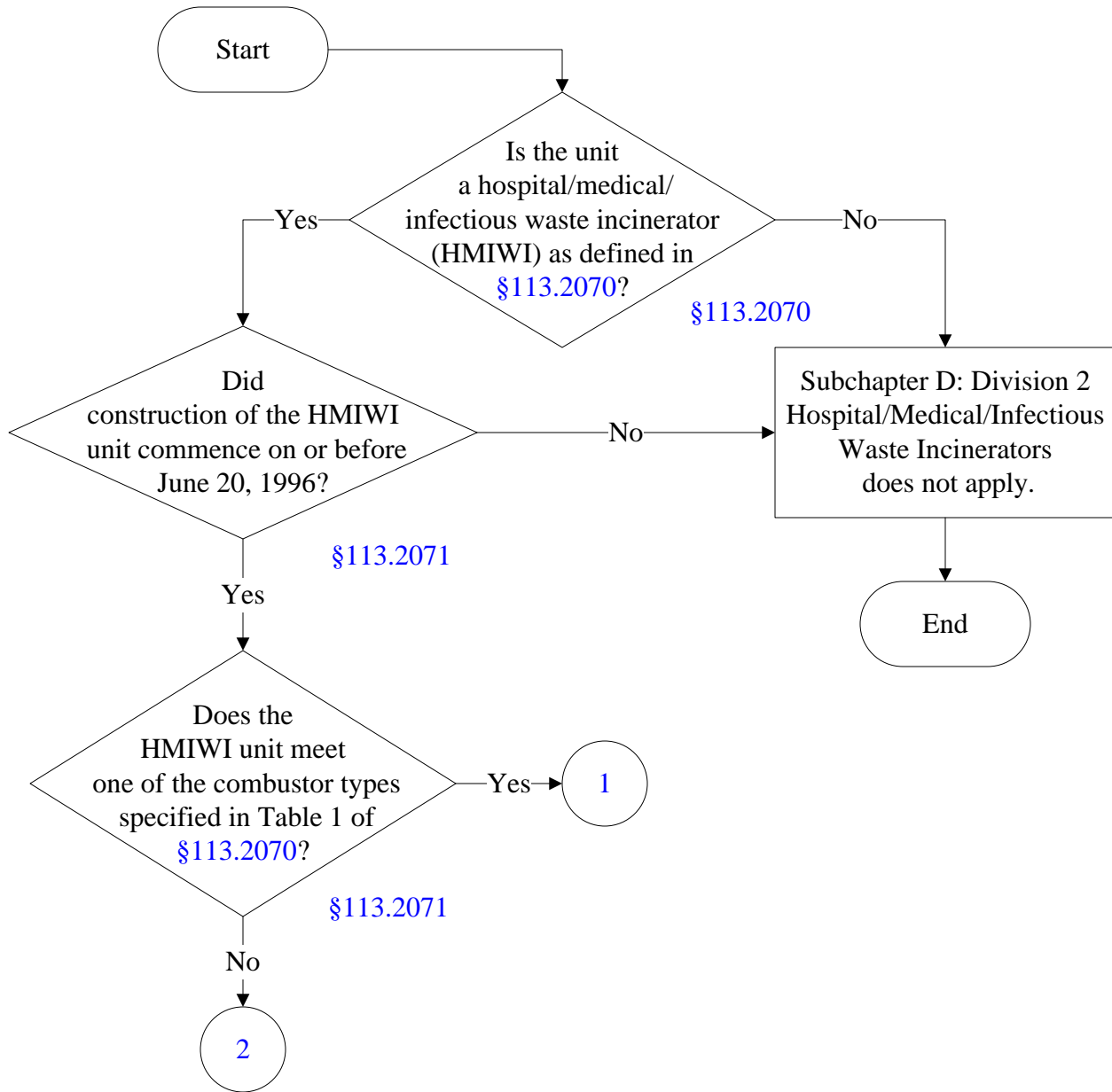




Below is a flowchart describing 30 TAC Chapter 113, Subchapter D, Division 2.

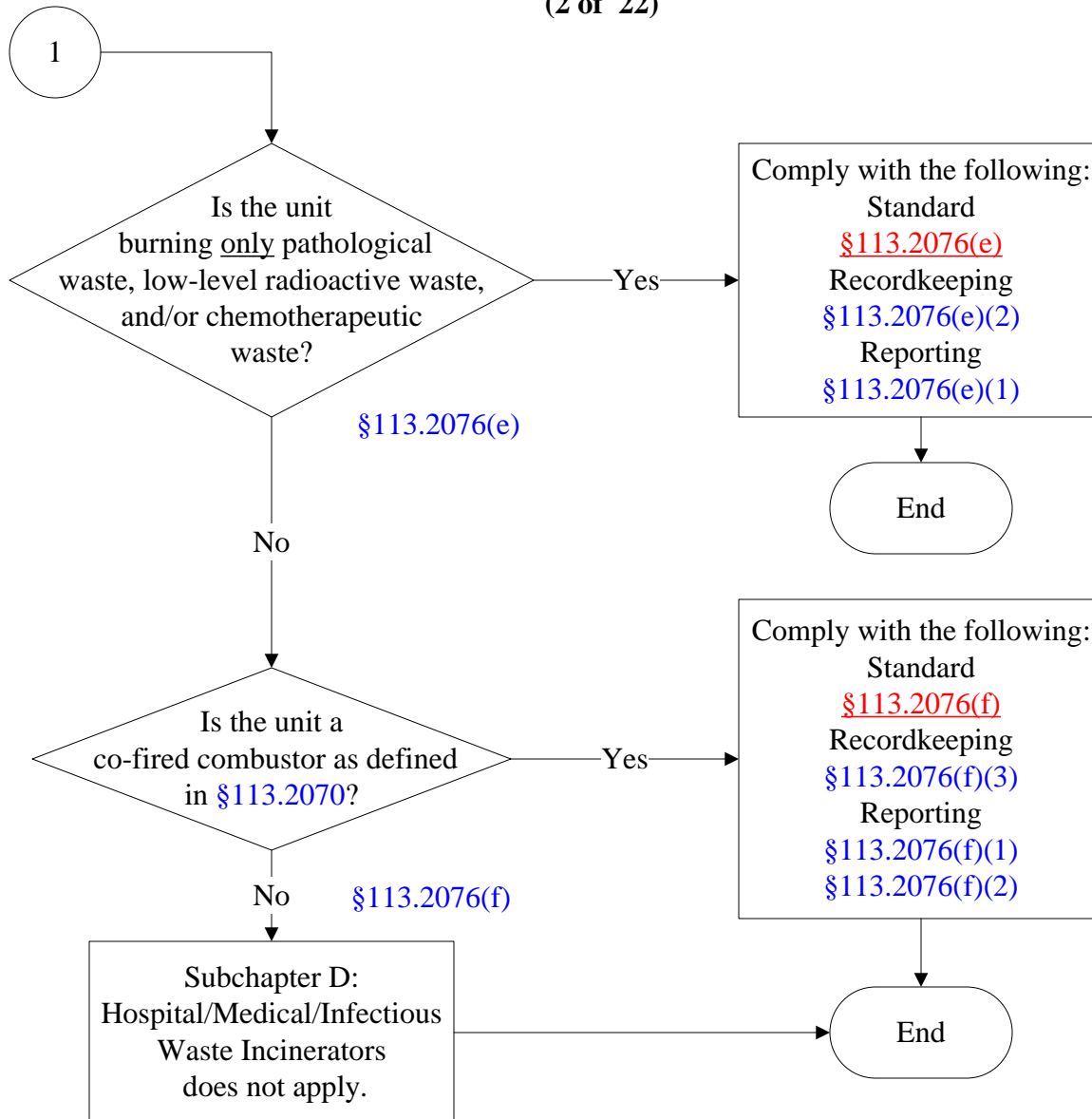

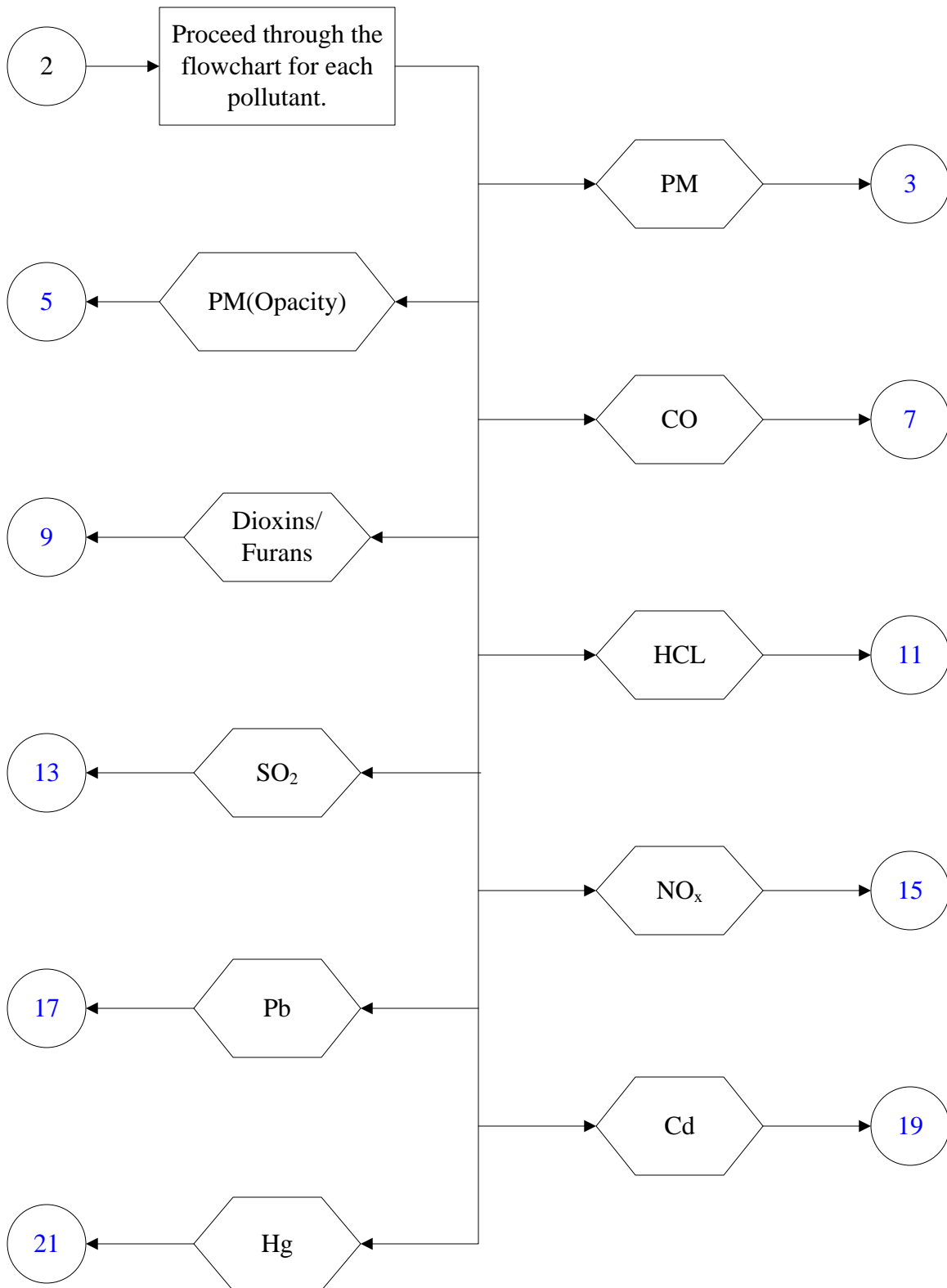

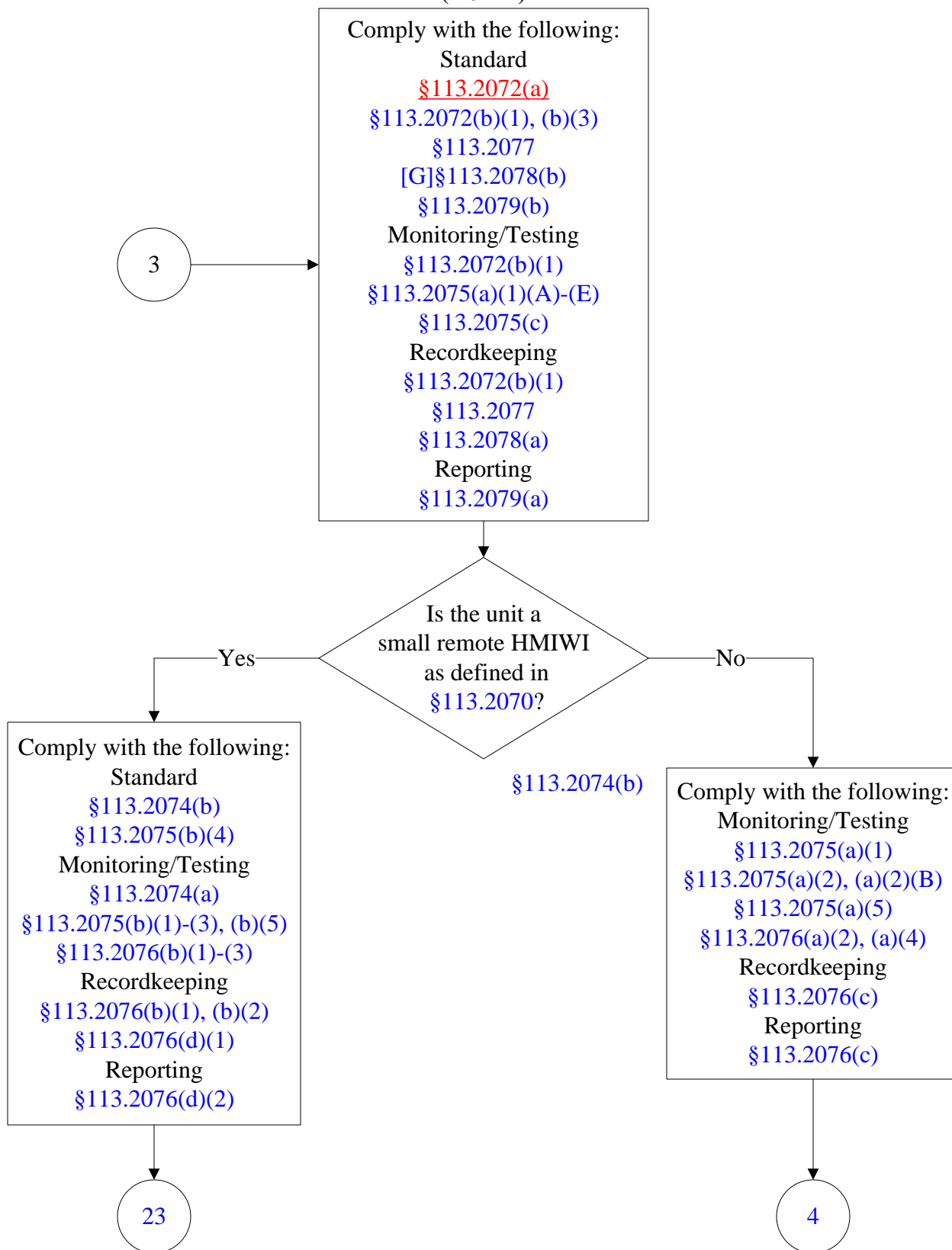

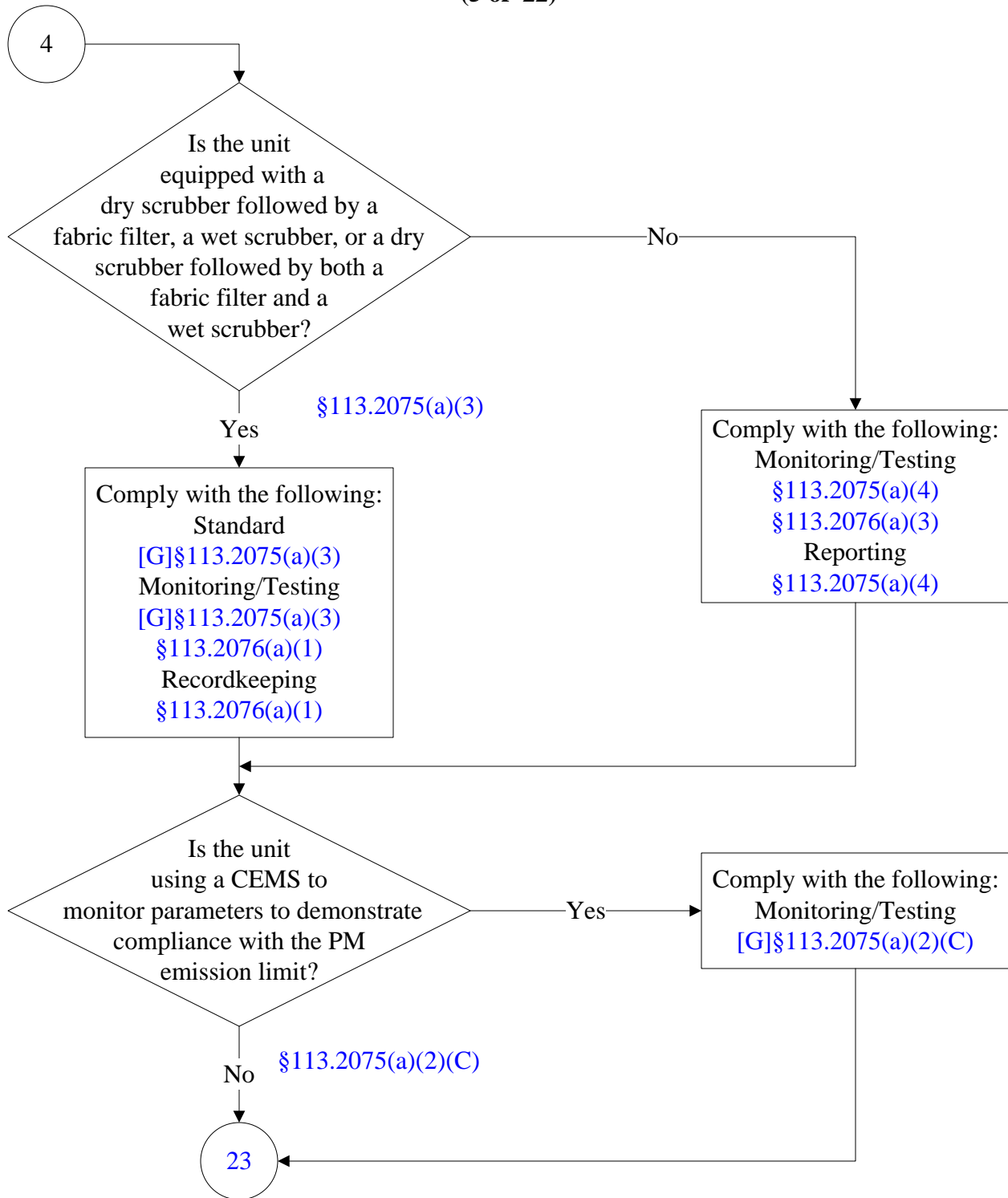

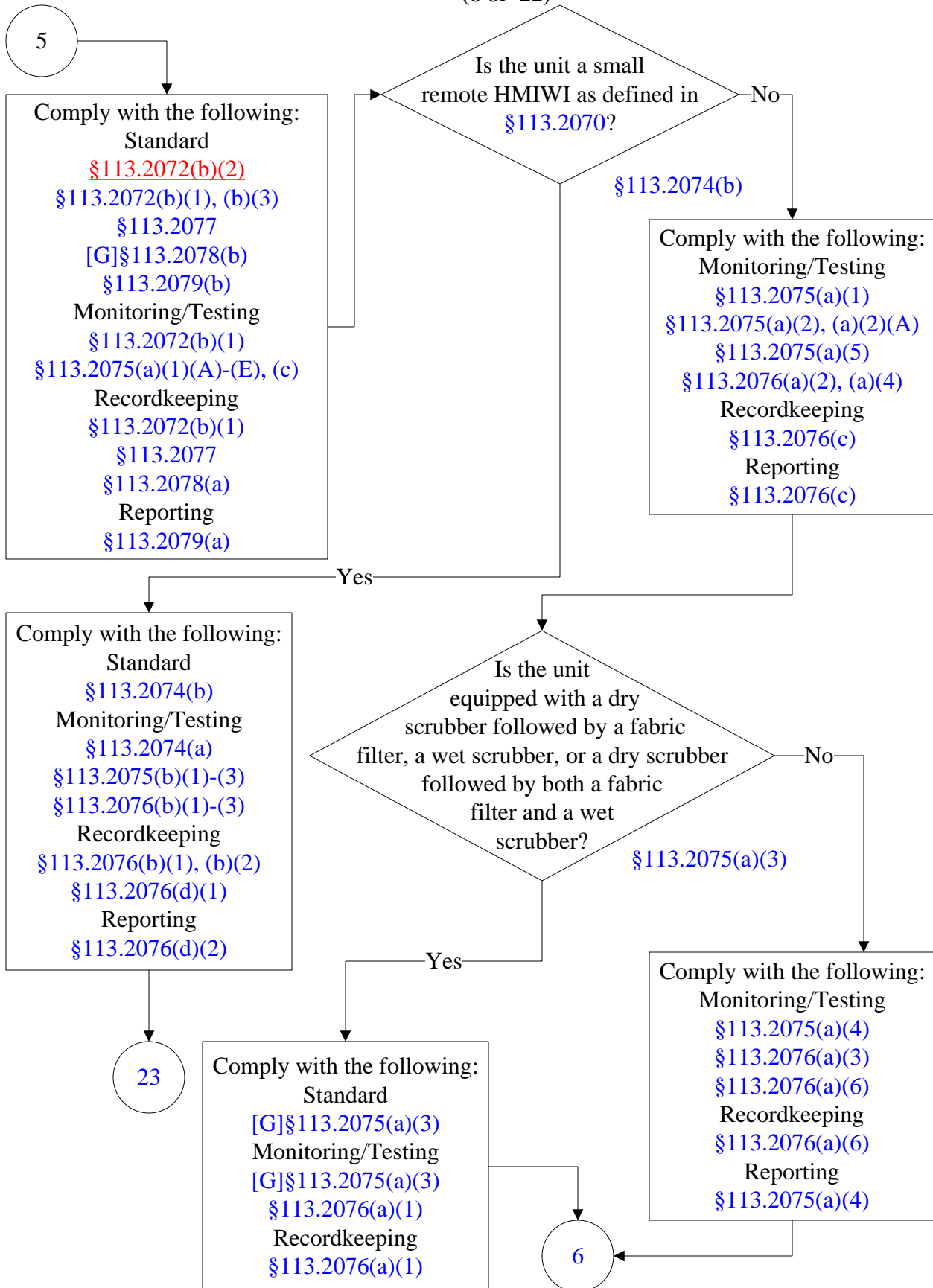

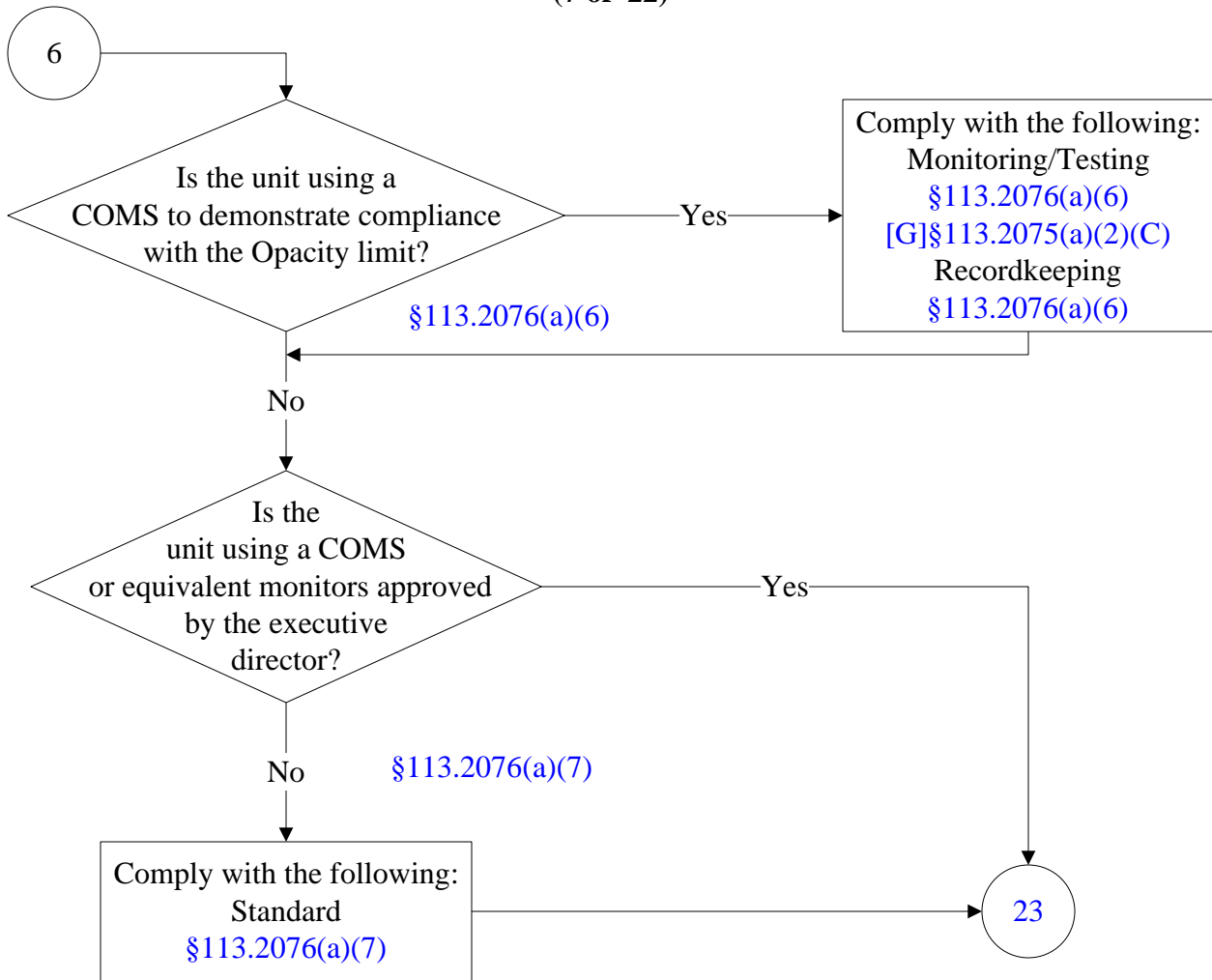

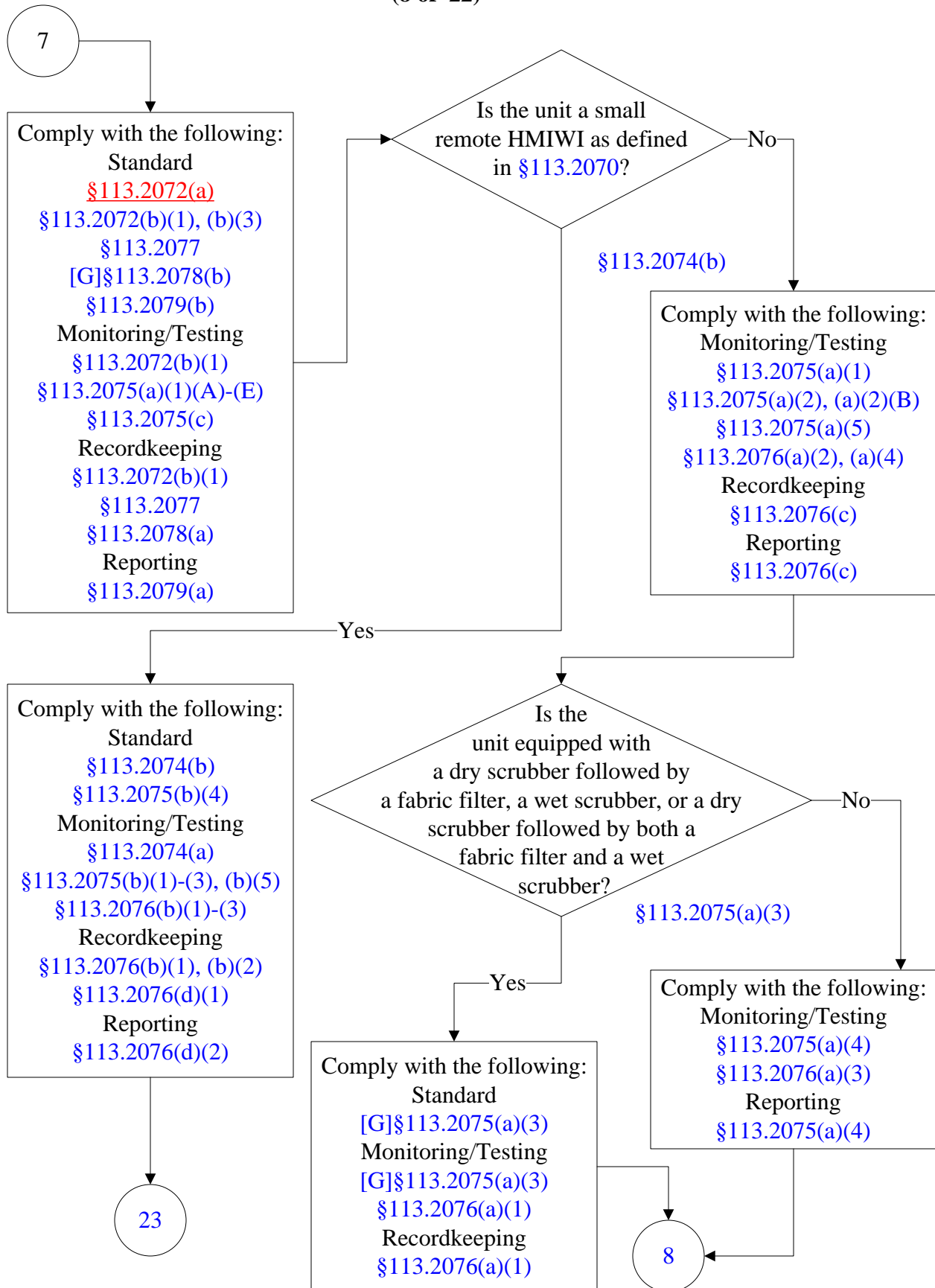

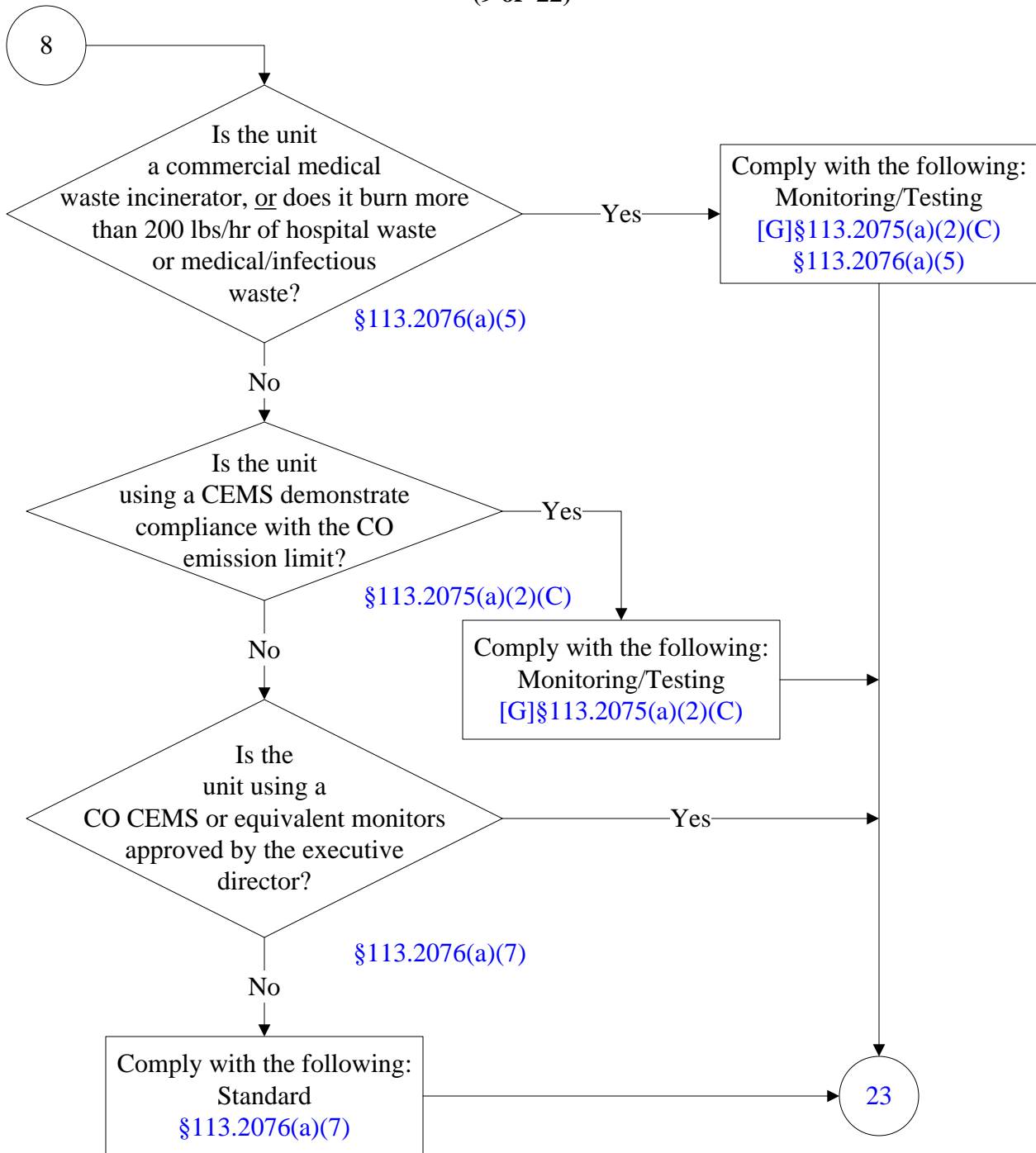

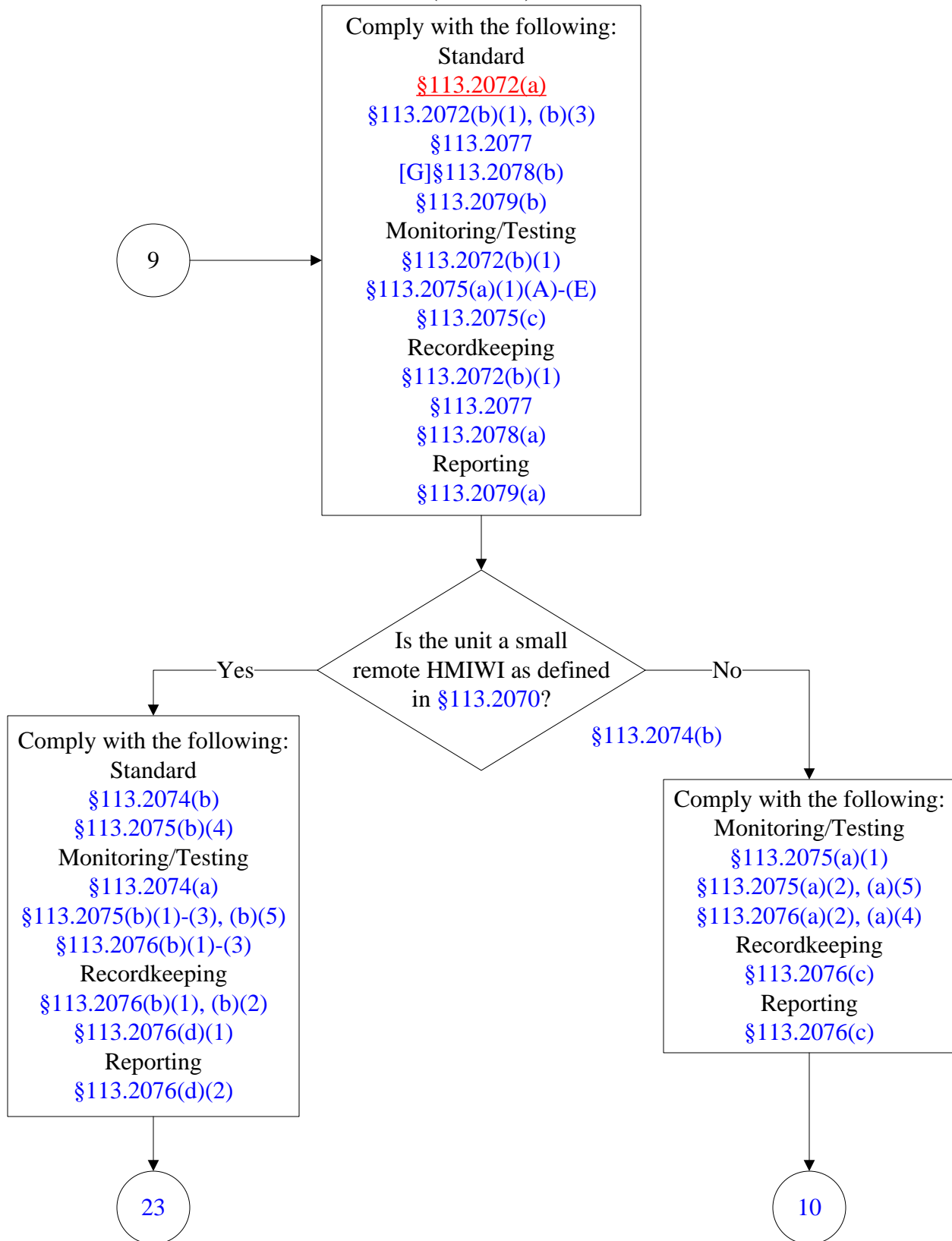

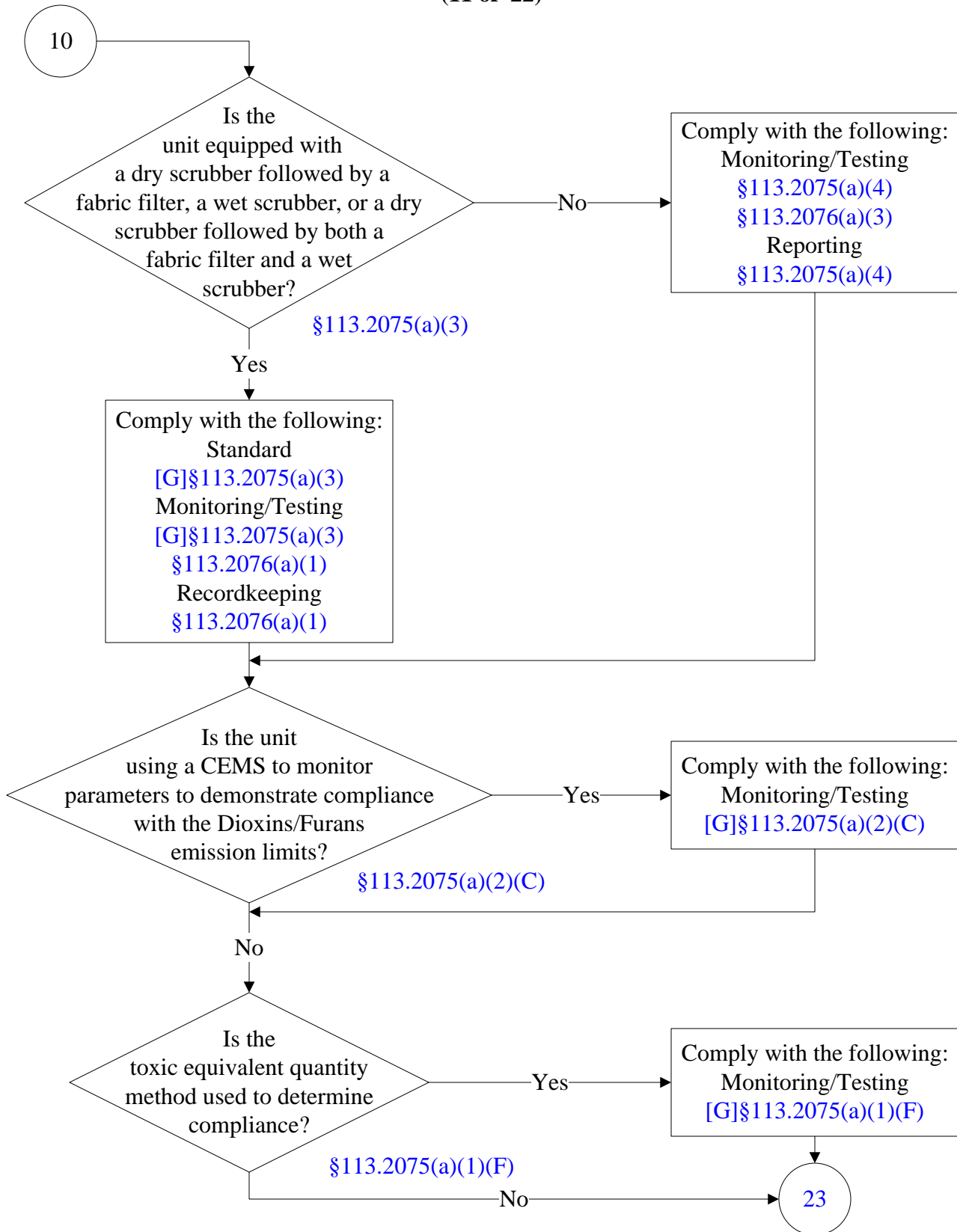

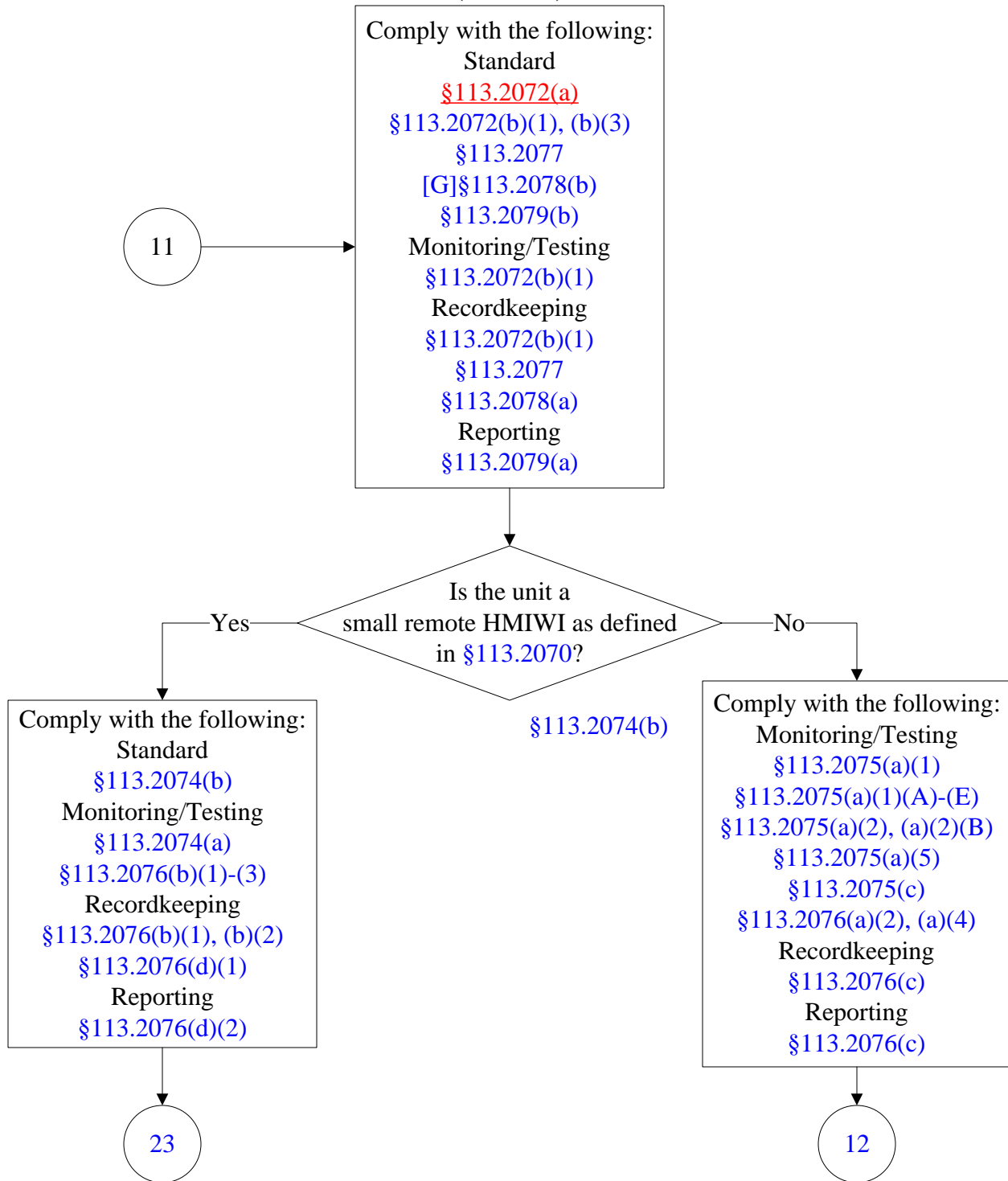

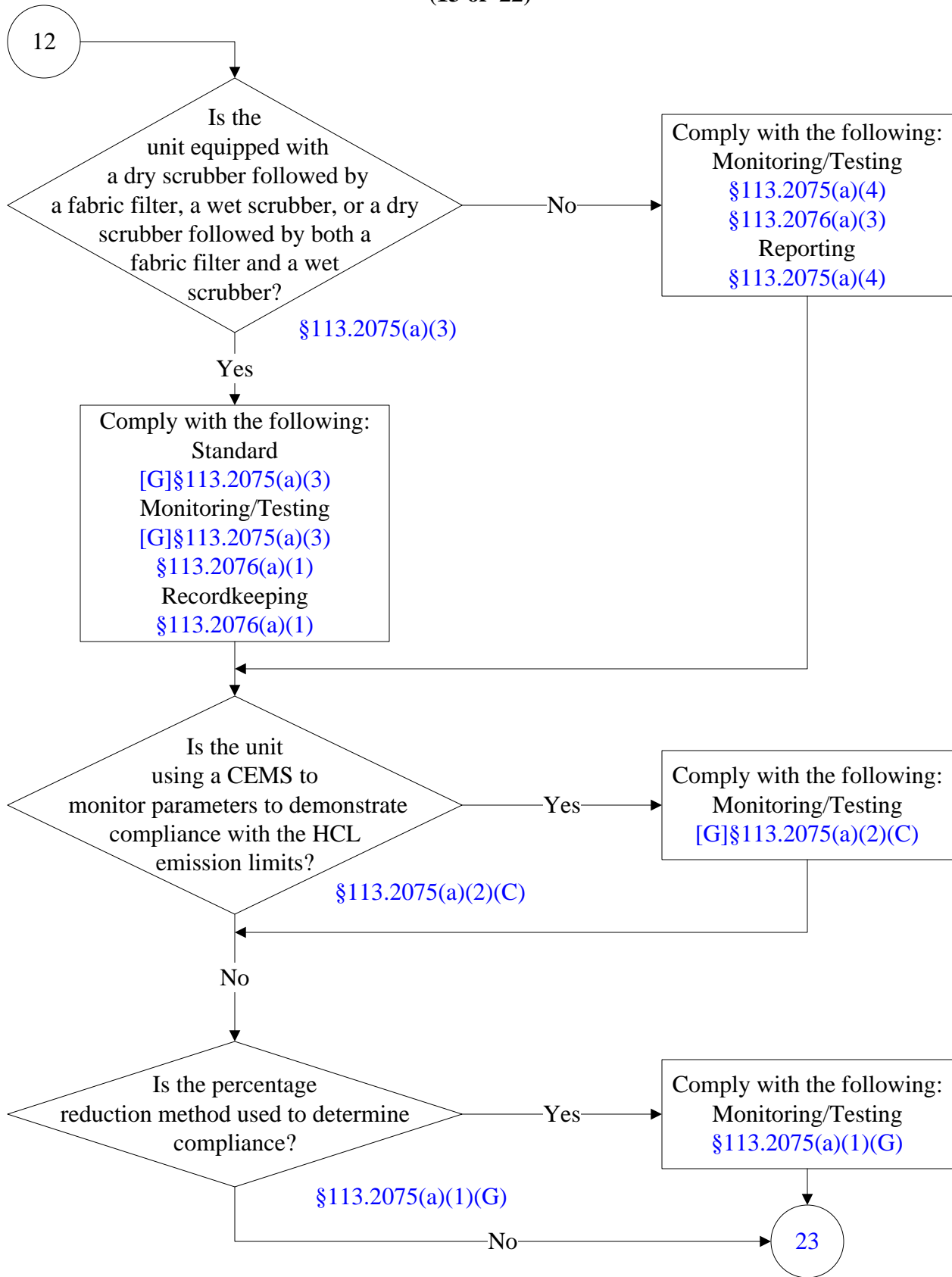

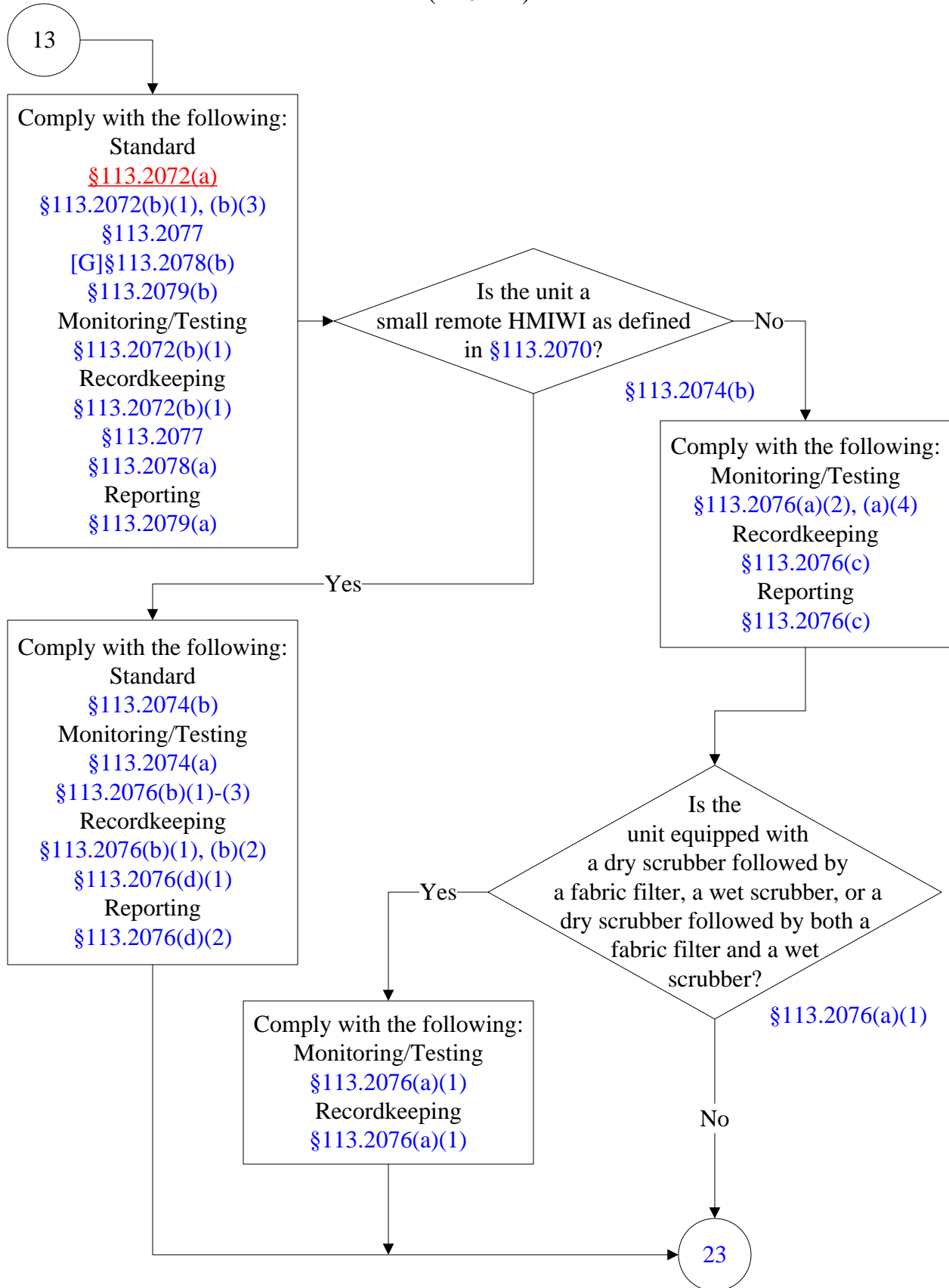

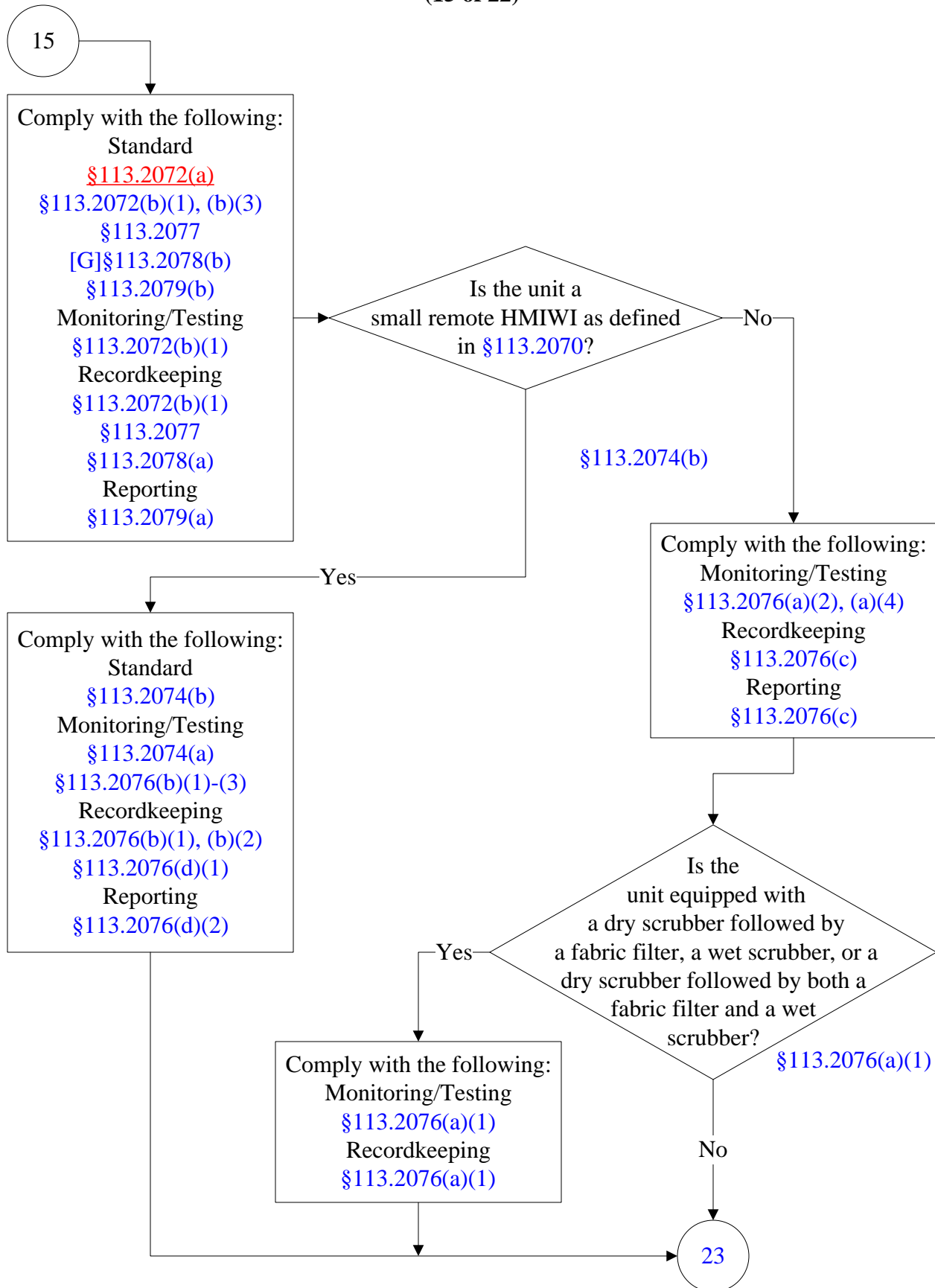

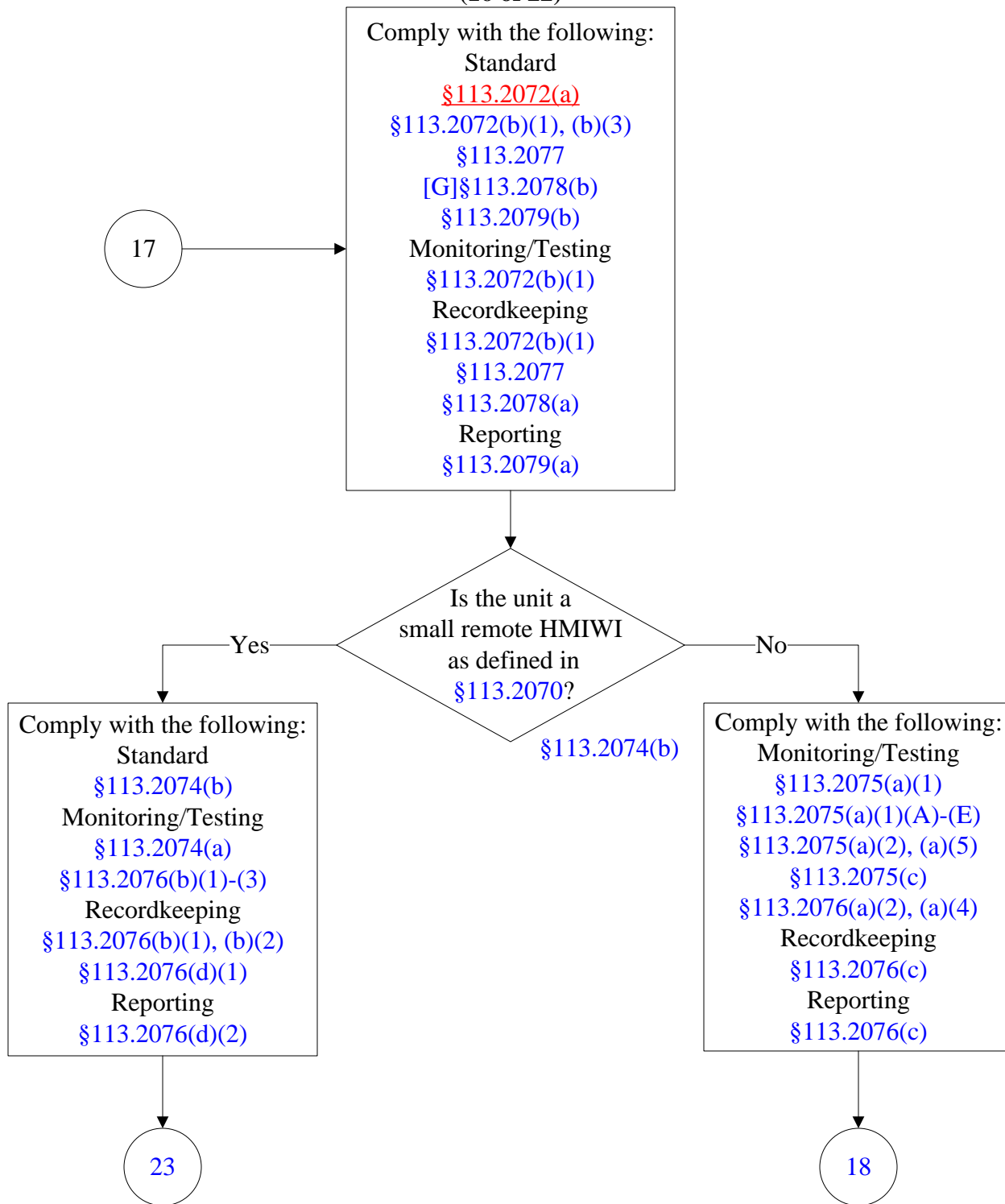

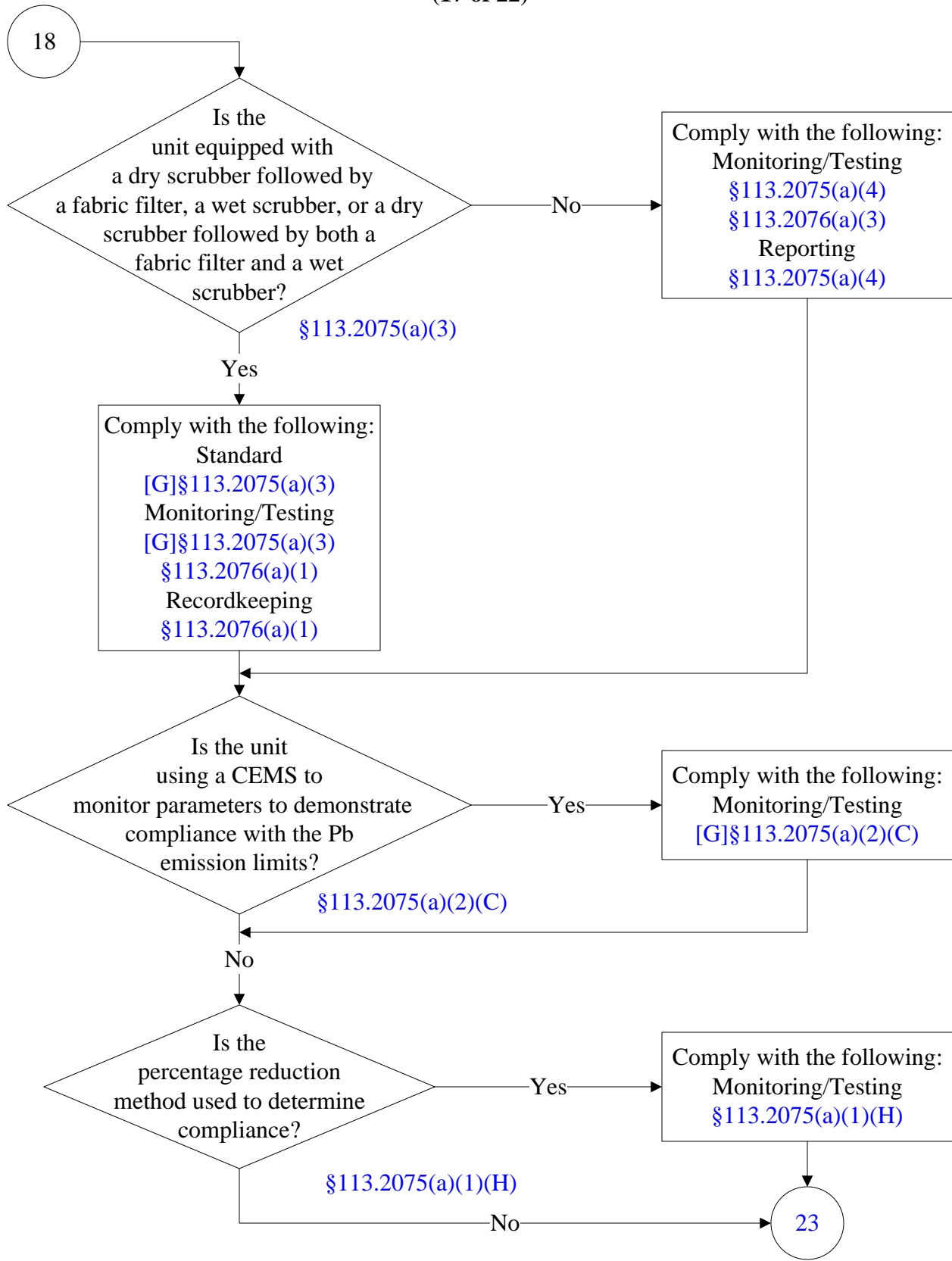

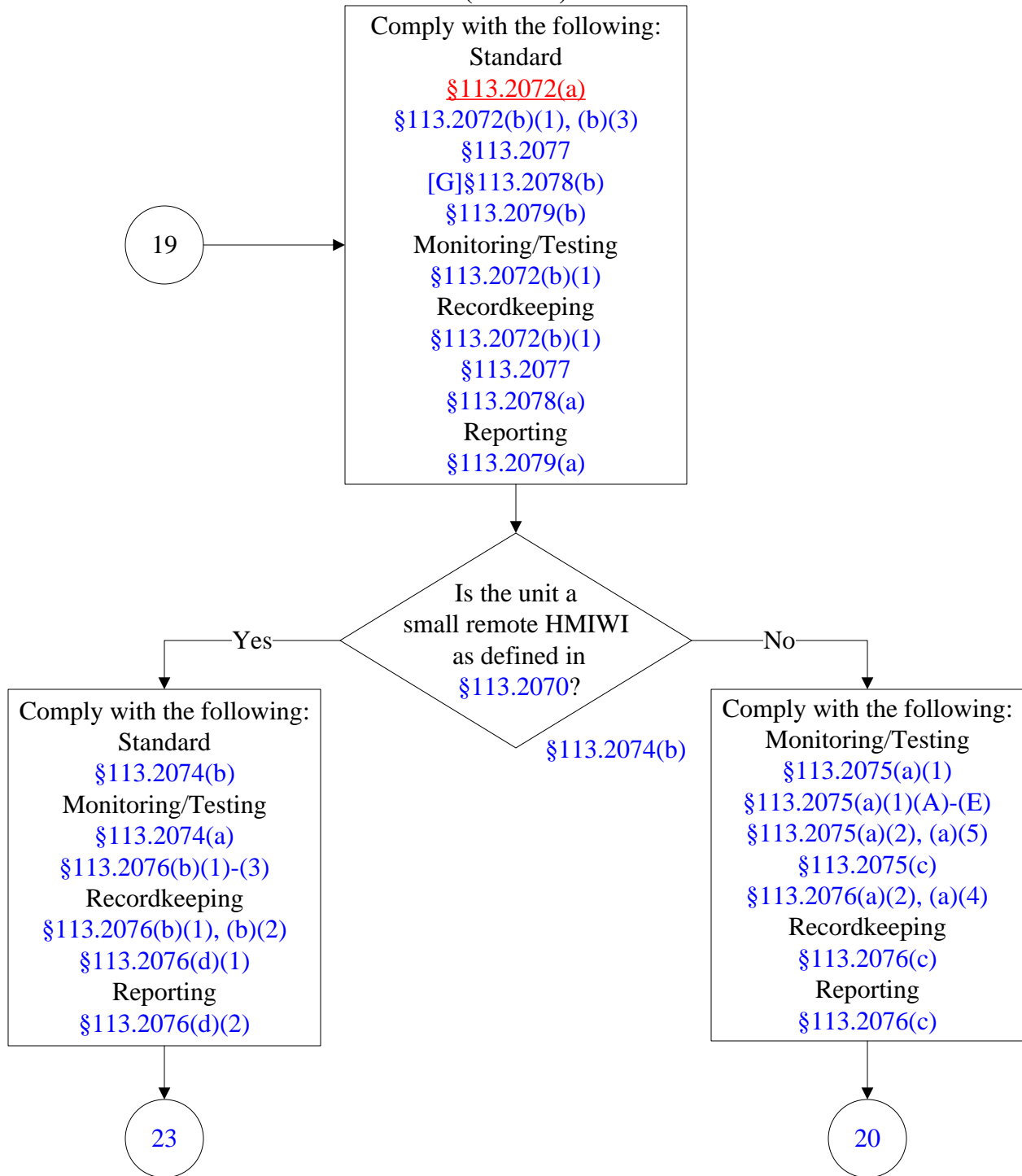

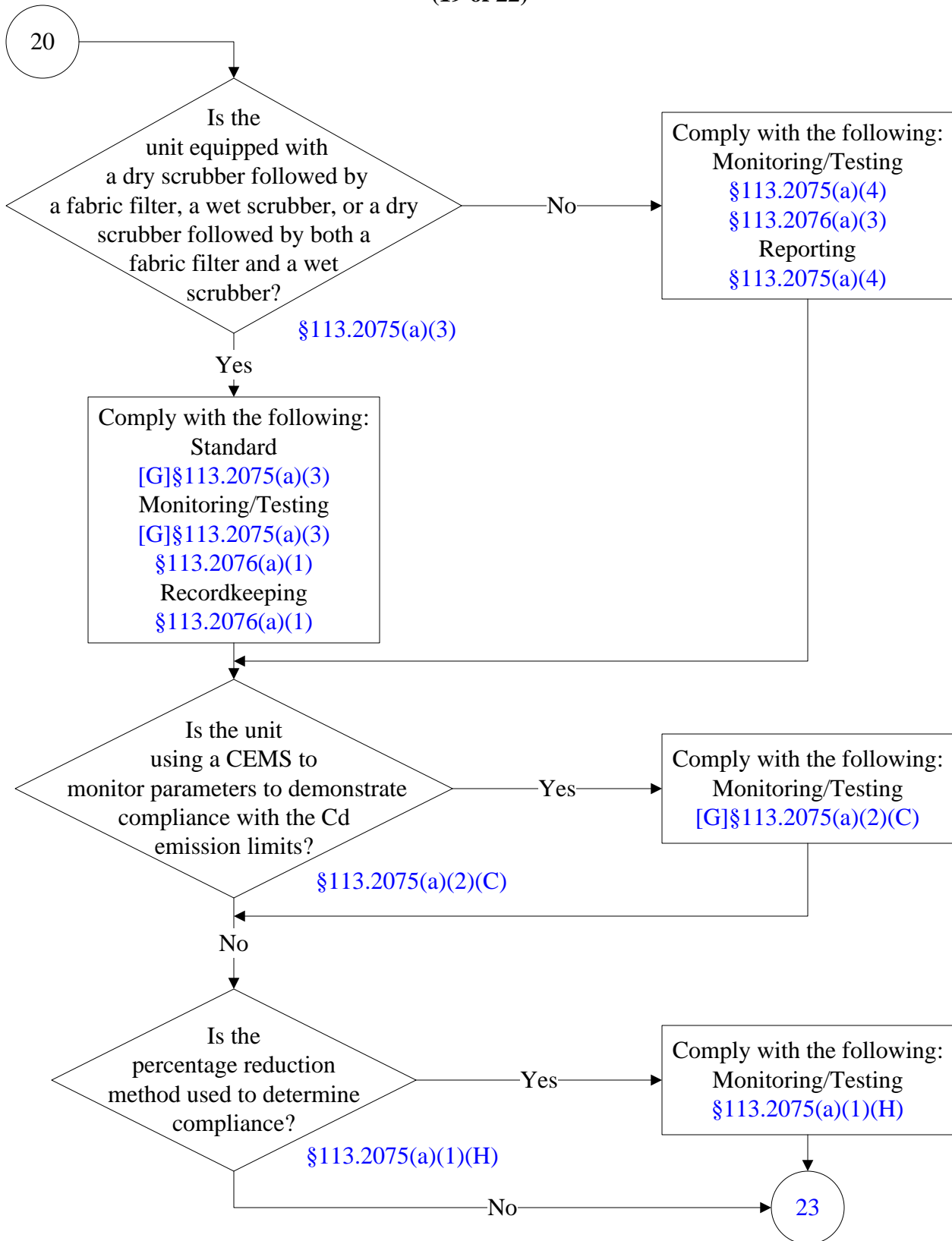

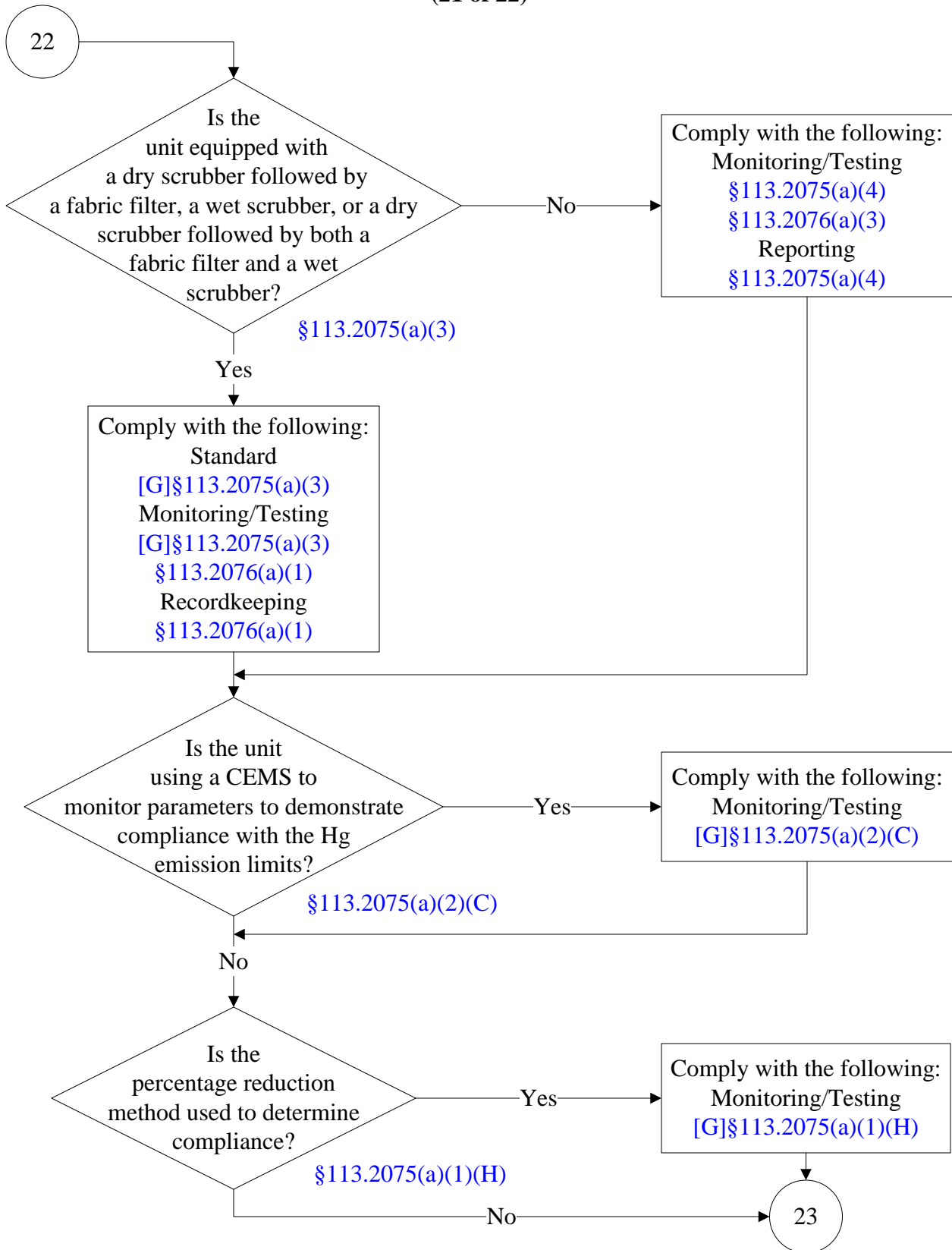
