**APPLICATION AND PRELIMINARY DECISION.** SOLUGEN CHEMICALS LLC, 14549 Minetta Street, Houston, TX 77035-6523, has applied to the Texas Commission on Environmental Quality (TCEQ) for an amendment to Air Quality Permit Number 160902, which would authorize modification to a Solugen Minetta Facility located at 14549 Minetta Street, Houston, Harris County, Texas 77035. **AVISO DE IDIOMA ALTERNATIVO.** El aviso de idioma alternativo en espanol está disponible en <u>https://www.tceq.texas.gov/permitting/air/newsourcereview/airpermits-pendingpermit-apps.</u> This application was submitted to the TCEQ on June 9, 2023. The amendment will authorize the addition of the following new air contaminants: hazardous air pollutants and organic compounds.

The executive director has completed the technical review of the application and prepared a draft permit which, if approved, would establish the conditions under which the facility must operate. The executive director has made a preliminary decision to issue the permit because it meets all rules and regulations. The permit application, executive director's preliminary decision, and draft permit will be available for viewing and copying at the TCEQ central office, the TCEQ Houston regional office, and at Morris Frank Library, 10103 Fondren Road, Brays Oaks Building, Houston, Harris County, TX 77035, beginning the first day of publication of this notice. The facility's compliance file, if any exists, is available for public review at the TCEQ Houston Regional Office, 5425 Polk Street Suite H, Houston, Texas.

**PUBLIC COMMENT/PUBLIC MEETING.** You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comment or to ask questions about the application. The TCEQ will hold a public meeting if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing. You may submit additional written public comments within 30 days of the date of newspaper publication of this notice in the manner set forth in the AGENCY CONTACTS AND INFORMATION paragraph below.

**RESPONSE TO COMMENTS AND EXECUTIVE DIRECTOR ACTION.** After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant and material or significant public comments. Because no timely hearing requests have been received, after preparing the response to comments, the executive director may then issue final approval of the application. The response to comments, along with the executive director's decision on the application will be mailed to everyone who submitted public comments or is on a mailing list for this application, and will be posted electronically to the Commissioners' Integrated Database (CID).
