NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR AN AIR QUALITY PERMIT

AIR QUALITY PERMIT NUMBER: PAL16

APPLICATION AND PRELIMINARY DECISION. Exxon Mobil Corporation, PO Box 4004, Baytown, TX 77522-4004, has applied to the Texas Commission on Environmental Quality (TCEQ) for renewal of Plant-wide Applicability Limit (PAL) Permit PAL16. The PAL permit is for the Chemical Plant in Baytown at 5000 Bayway Dr, Baytown, Harris County, Texas 77520. This application was submitted to the TCEQ on December 2, 2020. The PAL permit will renew the plant-wide applicability limit for an annual emission limitation from all facilities at the plant for the following air contaminant(s): carbon monoxide, hydrogen sulfide, nitrogen oxides, organic compounds, particulate matter including particulate matter with diameters of 10 microns or less and 2.5 microns or less, sulfur dioxide and sulfuric acid mist.

The executive director has determined that the emissions of air contaminants that will be subject to plant-wide applicability limits will not violate any state or federal air quality requirements and will not have any significant adverse impact on soils, vegetation, or visibility.

The executive director has completed the technical review of the application and prepared a draft permit which, if approved, would establish plant-wide applicability limits for the contaminants listed above under which the plant must operate. The permit application, executive director's preliminary decision, draft permit, and the executive director's preliminary determination summary, will be available for viewing and copying at the TCEQ central office, the TCEQ Houston regional office, and at the Sterling Municipal Library, 1 Mary Elizabeth Wilbanks Avenue, Baytown, Harris County, Texas, beginning the first day of publication of this notice. The facility's compliance file, if any exists, is available for public review at the TCEQ Houston Regional Office, 5425 Polk Street Suite H, Houston, Texas.

After the deadline for public comment, the executive director will consider the comments and prepare a response to all public comment. The response to comments, along with the executive director's decision on the application will be mailed to everyone who submitted public comments or is on a mailing list for this application.

EXECUTIVE DIRECTOR ACTION. The executive director may issue final approval of the application. The response to comments, along with the executive director's decision on the application will be mailed to everyone who submitted public comments or is on a mailing list for this application, and will be posted electronically to the CID.
