Plain Language Summary of Proposed Renewal/Revision of Air Quality General Operating Permit Number 518

Introduction

The Texas Commission on Environmental Quality (TCEQ or commission) is proposing the renewal and revision of Air Quality General Operating Permit (GOP) No. 518 under Title 30 Texas Administrative Code Chapter 122, Subchapter F (General Operating Permits).

The draft GOP contains revisions based on recent federal rule changes, which include updates to the Statement of Basis, the requirements tables, and updates to the terms. This renewal also corrects typographical errors and updates language for administrative preferences.

Public Comment and Public Meeting Information

TCEQ will offer a hybrid in-person and virtual formal public meeting on the proposed GOP renewal. The meeting will be offered in Austin on Monday, October 27, 2025, at 2:00 p.m. in Building F, Room 2210, at TCEQ's central office located at 12100 Park 35 Circle.
