The Texas Commission on Environmental Quality (TCEQ) has completed its review of three Aero-Stream products, name changes for ten previously approved Aero-Stream products, and name changes for five previously reviewed products whose approvals were denied.

An updated installation manual was received on March 2, 2023, for all of the products. NSF reports for the original fifteen products were also received with the name-change request. No NSF report was received for the new products to be reviewed.

The previous and current products names for the ten products that were approved for use in Texas as indicated in the letter dated February 22, 2023, are in the following table.


