The Texas Commission on Environmental Quality (TCEQ) reviewed your letter and five supporting documents that were submitted by email from Richard Corey on July 18, 2021, for the three above-referenced extended aeration activated sludge treatment products. On June 18, 2021, TCEQ received NSF's Standard 40 report for Clearstream 500N and its associated supplemental scale-up report for the 1000NCD, 1200NCD, and 1500 NCD products. After reviewing your letter, the five supporting documents, NSF's 500N Standard 40 report and its associated supplemental scale-up report, TCEQ has completed its review of the Clearstream Products 1000NCD, 1200NCD, and 1500NCD listed in the table below. The listed products are approved for use in Texas at capacities of 1000, 1200, and 1500 gallons per day, respectively. This approval is based on:

- The NSF authorization for the Clearstream Products 1000NCD, 1200NCD, and 1500NCD products to bear the NSF Mark, certifying that the listed products and their performances conform with NSF Standard 40 for Class 1 residential wastewater effluent. The basis for the issuance of the NSF Mark for the Clearstream Products 1000NCD, 1200NCD, and 1500NCD was scale-up analysis based on the Clearstream Product 500N, as conveyed by NSF on June 18, 2021.
