APPLICATION. URI, Inc., 641 E. FM 1118, Kingsville, Texas 78363, a uranium mining corporation, has applied to the Texas Commission on Environmental Quality (TCEQ) for a production area authorization to authorize uranium production within production area 1 and within the permitted area of Class III injection well area permit UR03095. The facility is located at 216 CR 135, George West 78022 in Live Oak County, Texas. TCEQ received the application on May 27, 2025. ADDITIONAL NOTICE. TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical review of the application is complete, the Executive Director may prepare a draft production area authorization and will issue a preliminary decision on the application. Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting on this application. After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

EXECUTIVE DIRECTOR ACTION. The application is subject to Commission rules which direct the Executive Director to act on behalf of the Commission and provide authority to the Executive Director to issue final approval on the application for the production area authorization.
