Protecting Texas by Reducing and Preventing Pollution

Dear Facility Contact:

In November 2021, the Texas Commission on Environmental Quality (TCEQ) approved a **45%** fee increase for the industrial and hazardous waste (IHW) management fee and agreed to phase in the overall increase over four years. The first phased increase of 12% occurred in March 2022. In accordance with 30 Texas Administrative Code Section 335.325(j)(3), the executive director has conducted an annual review of the IHW management fee and is proceeding with the second phase of the increase.

The fee rate per ton will increase by **23% over the original (2021) rate, or approximately 9.8% over the current (2022/2023) rate**, for waste managed on or after **September 1, 2023**. This increase will be reflected in the September monthly report, due by October 25, 2023.

On September 1, 2023, TCEQ will begin assessing fees according to the following schedule:
