Form Instructions and Notes

Instructions:

Who should use this form? Non-commercial hazardous waste management facilities authorized to accept, collect, and dispose of hazardous wastes should submit this form. The form shall accompany each monthly payment of a non-commercial hazardous waste management fee.

When are fee payments due? Payments are due by the 25th day following the end of the month for which payment is due. Fees must be paid by ePay, check, certified check, or money order to the TCEQ.

<u>How do I report waste generation quantities on this form?</u> Provide waste generation quantities on the attached tables. The quantities shall be based on the total of weight or volume of a waste except for wastes which are disposed of in an underground injection well, in which case the fee shall be based on the dry weight of the waste, measured in dry weight tons (dwt), as defined in 30 TAC §335.322 (relating to Definitions) and 30 TAC §335.326 (relating to Dry Weight Determination).

Notes

- All weights are in short tons (2,000 pounds) except for underground injection which is in dry weight tons.
- This report shall be submitted to meet the requirements of 30 TAC §335.329, Records and Reports.
- This report must be submitted regardless of whether any storage, processing, or disposal of hazardous waste was conducted during the subject month.
- This report shall accompany each monthly payment of a non-commercial hazardous waste management fee due under 30 TAC §335.325, Industrial Solid Waste and Hazardous Waste Management Fee Assessment.
- As authorized by 30 Texas Administrative Code (TAC) §335.331, operators of waste management facilities submitting late reports concerning the management of waste under the Health and Safety Code, §361.136 are subject to an assessment of late payment penalties and interest in accordance with 30 TAC Chapter 12.
