## Revised Notice of Application and Preliminary Decision for Hazardous Waste Permit/Compliance Plan Modification

Permit/Compliance Plan No. 50099

APPLICATION AND PRELIMINARY DECISION. Shell USA, Inc., 5900 Highway 225, Deer Park, Texas 77536-2434, a chemical manufacturing plant and former petroleum refinery, has applied to the Texas Commission on Environmental Quality (TCEQ) for a Class 3 Modification to Permit/Compliance Plan No. 50099 to authorize the transfer of the operational controls of the refinery part of the compliance and corrective action monitoring, and certain waste management units from Permit No. 50099 to Deer Park Refining LP., Permit No. 50422. The facility is located at the address stated above in Harris County. The TCEQ received this application on June 27, 2022. The TCEQ Executive Director has reviewed this action for consistency with the goals and policies of the Texas Coastal Management Program (CMP) in accordance with the regulations of the Coastal Coordination Council (CCC) and has determined that the action is consistent with the applicable CMP goals and policies.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit/compliance plan. The draft permit/compliance plan, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit/compliance plan, if issued, meets all statutory and regulatory requirements. The permit/compliance plan application, Executive Director's preliminary decision, and draft permit/compliance plan are available for viewing and copying at Deer Park Public Library, 3009 Center Street, Harris County, Deer Park TX 77536.

PUBLIC COMMENT / PUBLIC MEETING. The applicant held a public meeting at 1:15 PM on September 28, 2022, at Jimmy Burke Activity Center: 500 W. 13th Street, Deer Park, Texas 77536. You may submit additional public comments or request another public meeting about this application. You may submit public comments or request that the TCEQ hold a public meeting on this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public

interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material or significant public comments. Unless the application is directly referred for a contested case hearing, the response to comments will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name; address, phone; applicant's name and permit number; the location and distance of your property/activities relative to the facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you raised during the comment period and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn.

If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law that are relevant and material to the Commission's decision on the application submitted during the comment period.

**EXECUTIVE DIRECTOR ACTION.** The Executive Director may issue final approval of the application unless a timely contested case hearing request or request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. To be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
