Conflict of Interest Questionnaire for Candidates for Position Representing the Public

Interested Persons

An *interested person* is a person who seeks official action from the Commission. Interested persons include individuals, businesses, groups, or governmental entities that:

- Are regulated by the Commission (such as permit holders or registered contractors);
- Are parties in Commission proceedings (including non-profit associations);
- Transact business with the Commission (such as vendors); or
- Represent members of those groups (such as law firms, consulting firms, or trade associations).

Examples of relationships or associations that could cause conflict or be viewed as impeding an impartial decision include:

- A family member, friend, or ex-spouse who is employed by, or who is, an interested person
- An employee or family member having substantial, direct investments in an interested person.

You may have a substantial, direct investment in an interested person if:

- You have a controlling interest in the business;
- You own more than 10% of the voting interest in the business or you are entitled to more than 10% of the profits, proceeds, or capital gains of the business;
- You own more than \$25,000 of the fair market value of the business;
- You serve on the governing board, as an officer of, or as an employee of the business.
