Advisory Council Application Form

The Municipal Solid Waste Management and Resource Recovery Advisory Council (Advisory Council) was created by the 68th Legislature in 1983 and consists of 18 members who serve staggered six-year terms. The composition of the Advisory Council is prescribed in Section [363.041](#) of the Texas Health and Safety Code.

The Advisory Council performs several duties including:

- reviewing the effect of state policies and programs on Municipal Solid Waste (MSW) management;
- making recommendations to the TCEQ on matters relating to MSW management;
- recommending legislation to encourage the efficient management of MSW;
- recommending policies for the use or distribution of funds for the Regional Solid Waste Grants Program;
- recommending special studies and projects related to MSW management.

Applicants and nominees will be evaluated based upon the application, materials submitted, letters of reference, and solid waste management experience. Appointments will be made by the TCEQ commissioners at an Agenda meeting once nominations are reviewed and approved.
