Good afternoon Mr. Tewelde,

On behalf of the Town of Van Horn, Civil & Environmental Consultants, Inc. (CEC) is responding to the March 15, 2024 email which contained a request to review and address the comments listed below for the waste acceptance rate increase permit modification. The comments are in regular font, and the responses are in italic font.:

1. For the scale outside the landfill permit, provide a statement demonstrating that there is access control (such as a gate) in place to ensure compliance with 30 TAC [§330.131](#).

*While the scale is outside the permit boundary, two lockable gates provide access control for the landfill scale. The lockable gates and landfill scale are shown on Figure 1.*

2. Please use the customer number (CN) for Town of Van Horn CN602297111 throughout the application. The CN provided on form TCEQ-20650 and Core Data Form TCEQ 10400 are for City of Van Horn associated with the superseded permit number 693.

*The Core Data form and TCEQ Form 20650 have been revised to include the Town of Van Horn customer number CN602297111. A Waste Permits Division Correspondence Cover Sheet, revised TCEQ Form 20650, Attachments 1-4 from the original permit modification, the revised Core Data Form (Attachment 5), and Attachments 6 and 7 from the original permit modification have been compiled and is attached for your review.*

3. Update the Site Operating Plan as needed to reflect changes required pursuant to 30 TAC [§330.127\(2\)](#).

*The Town of Van Horn has indicated there have been no changes pursuant to 30 TAC [§330.127\(2\)](#); therefore, the Site Operating Plan has not been changed.*

4. Provide information a statement or information as required by [§330.59\(c\)\(3\)\(B\)](#), either including all mineral interest ownership or indicating that no mineral interest ownership exists at the facility property.

*The Town of Van Horn has indicated there is no mineral interest ownership which exist at the facility property. Additional information can be provided by the Town of Van Horn if requested by the TCEQ.*
