

Dear Ms. Ross:

The purpose of this permit modification prepared by Weaver Consultants Group, LLC (WCG) is to modify the site's existing Attachment 14 – Landfill Gas Management Plan (LGMP) to incorporate the recently installed 2024 landfill gas collection and control system (GCCS) expansion into the existing LGMP for the Polk County Landfill. This permit modification is being submitted as a public notice permit modification in accordance with Title 30 of the Texas Administrative Code (30 TAC), §305.70(k)(3) as requested by the Texas Commission on Environmental Quality (TCEQ) in a letter dated July 30, 2024.

Additional/replacement pages for the site's Attachment 14 – LGMP are included in Attachment 1. The following summarizes the changes made to the site's existing LGMP.

- A second cover page has been added to be placed behind the Attachment 14 – LGMP original cover page. The purpose of this page is to provide a continuous record of modifications to LGMP and to clearly identify the responsible engineer for each.
- Page ii of the Table of Contents has been revised to indicate the addition of Appendix C.
- Appendix C has been added to the LGMP to describe the site's recent remediation measures. In addition, Appendix C-1: Remediation Measures Drawing has been added to include the as-built drawing of the installed remediation measures.

System Description

The primary purpose of the 2024 GCCS expansion is to collect landfill gas (LFG) from the landfill for environmental control and to minimize the potential for offsite migration.

The GCCS expansion included the installation of nine LFG extraction wells (7 new and 2 re-drills), conversion of three passive vents to active vents, LFG collection piping, LFG collection piping, associated new LFG system components, and abandonments of existing well and lateral piping as shown on Drawing 14C-1. In addition, to assist in extracting LFG from the landfill as well as to help prevent potential odors at the site, a toe drain was installed as shown on Drawing 14C-1.

Each vertical extraction well, converted active vent, and toe drain connection were fitted with a wellhead valve assembly. The wellhead is equipped with an adjustment valve to regulate the applied vacuum and flow of LFG. The wellhead is also equipped with monitoring ports to enable the system operator to measure gas composition, pressure, flow rate, and temperature. The wellheads were connected to lateral piping, which conveys the flow of LFG into the lateral/header pipe and then to the existing blower/flare facility for combustion. In addition, LFG isolation valve was also installed along the new piping to provide the ability to isolate portions of the system.

Permit Modification Justification

The site understands the importance of maintaining effective environmental controls at the landfill. Please process this permit modification request per 30 TAC §305.70(k)(3). It is our understanding that public notice will be required for this permit modification. Please note that an adjacent property owner's map, along with a list of the property owners' names and addresses, are included in Attachment 3. An applicant certification consistent with 30 TAC §305.44 and §305.70(f) is included on Page 5 of the TCEQ-20650 Form in Attachment 4 of this submittal. In accordance with Title 30 TAC §330.59(h)(1), a \$150 application fee has been submitted to TCEQ as documented on Page 1 of the TCEQ-20650 Form.

One original and one copy of this permit modification are provided for your use and distribution. To facilitate your review, we have included copies of the LGMP revisions in both clean and redline/strikeout formats. In addition, one copy of this submittal has been provided to the TCEQ Region 10 office. A copy of this submittal was also placed in the site operating record.




