Application and Preliminary Decision. City of Uvalde has applied to the Texas Commission on Environmental Quality (TCEQ) for a permit modification to authorize changes to the landfill gas management plan to reflect current site conditions and incorporate documentation on the landfill gas monitoring system, the gas extraction system, and details relating to landfill gas remediation efforts. The facility is located at 3774 FM 481, Uvalde, Texas 78801, in Uvalde County, Texas. TCEQ received this application on March 13, 2025. The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit modification. The draft modification, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit modification, if issued, meets all statutory and regulatory requirements.
