The following activities have already occurred:		
A public town hall meting was held on September 12, 2023 at Frenship Alcove Trails Middle School (7510 63rd St, Lubbock, Texas, 79407). This was a 3 hour general information meeting introducing the project, project scope, and timing. Attendees were allowed to provide verbal comments.		
In accordance with the City of Lubbock zoning requirements, to re-zone the facility from low density single family housing to light industrial zoning, three public meetings were held. The first meeting was held at a regularly scheduled City Planning and Zoning Commission meeting on February 1, 2024. This was an open public meeting and the public was allowed to provide comments. Following approval by the Planning and Zoning Commission, the proposed zoning change was read aloud at two City Council meetings (February 13, 2024 and February 27, 2024). Both meetings were open public meetings, and the public was allowed to provide comments.
