Provide a brief description of planned activities.

The proposed facility is a Type I municipal facility that will accept various types of waste, including municipal, commercial, institutional, and recreational solid waste, along with nonhazardous industrial waste, petroleum-contaminated soil, wastewater treatment facility sludge, and special waste. The facility will contain a citizens' collection station with containers for household waste, as well as for white goods and tires that will be hauled off-site for disposal. The estimated volume for the first year of operation is approximately 217 tons per day, or a total of 61,100 tons, assuming 281 days of operation. The facility will serve a population of approximately 45,000 from Reeves County and adjacent counties.

The facility has been designed to meet or exceed TCEQ requirements, and will be protective of public health and safety. The project design includes the landfill liner, leachate collection system, gas monitoring network, stormwater management system, groundwater monitoring network, and final cover.
