In all operations (including customer rentals) the Owner currently utilizes twelve 30 yard open containers, four 20 yard open containers, and three 40 yard closed containers.

Please note that the Owner parks the trucks and spare boxes on site.

A maximum of 45 tons waste will be stored at any one point in time at the facility. At the present time, municipal solid waste makes up approximately 95% of the incoming waste stream to this facility, while construction debris amounts to approximately 3% and white goods approximately 2%.

Municipal solid waste will be stored at the facility for an average length of time of two days up to a maximum length of time not to exceed 5 days. Local Sanitation curbside garbage trucks and private residents enter the compactor building and transfer their loads of municipal solid waste to the of the facility's 5.0 cubic yard compactor. The solid waste is then compacted and deposited to a 40 cubic yard covered container where it awaits transport for final disposal. Compaction of the municipal solid waste will normally be conducted daily when the facility is in operation. This compacted municipal solid waste will then be transported to a TCEQ approved landfill for final disposal.

Metal and white goods (such as refrigerators, washers, dryers, etc.) deposited at the site will be accumulated on the existing concrete slab in the southwest corner of the site and they are typically hauled to a recycler of white goods once or twice a year as needed.

Construction debris is deposited in a dedicated 40 CY container and is transported as required to a TCEQ approved landfill on an as-needed basis when full, so its average storage time on site varies.





- One roll-off truck to remove the dumpsters from the transfer station along with some outside customer rental boxes
- In all operations (including customer rentals) the Owner currently utilizes twelve 30 yard open containers, four 20 yard open containers, and three 40 yard closed containers.

Please note that the Owner parks the trucks and spare boxes on site.

A maximum of 45 tons waste will be stored at any one point in time at the facility. At the present time, municipal solid waste makes up approximately 95% of the incoming waste stream to this facility, while construction debris amounts to approximately 3% and white goods approximately 2%.

Municipal solid waste will be stored at the facility for an average length of time of two days up to a maximum length of time not to exceed 5 days. Local Sanitation curbside garbage trucks and private residents enter the compactor building and transfer their loads of municipal solid waste to the of the facility's 5.0 cubic yard compactor. The solid waste is then compacted and deposited to a 40 cubic yard covered container where it awaits transport for final disposal. Processing Compaction of the municipal solid waste will normally be conducted daily when the facility is in operation. This compacted municipal solid waste will then be transported to either a TCEQ approved landfill in Texas for final disposal or to a LCEQ approved landfill in Louisiana for final disposal (the exact destination varies depending on disposal fees and fuel costs at any given time).

Metal and white goods (such as refrigerators, washers, dryers, etc.) deposited at the site will be accumulated on the existing concrete slab in the southwest corner of the site and they are typically hauled to a recycler of white goods once or twice a year as needed.

Construction debris is deposited in a dedicated 40 CY container and is transported as required to a TCEQ or LCEQ approved landfill on an as-needed basis when full, so its average storage time on site varies.
