**Application and Preliminary Decision**. Waste Management of Texas, Inc., has applied to the Texas Commission on Environmental Quality (TCEQ) for a permit modification to authorize optional design elements to the existing alternative final cover system. The draft modification, if approved, would establish the conditions under which the facility must operate.
