## Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG920043

**Application.** Piertsje DeBoer Vanderlei and Kornelis Wilt Vanderlei, 1054 US Highway 84, Amherst, Texas 79312 have applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicants have renamed the land management units (LMUs) without changing the acreage of the LMUs, and added Wells #29, #30 and #31 to the facility. The NMP and the facility maps have been updated to reflect the new LMU names and additional wells. The notice of change application and the updated NMP were received by TCEQ on August 16, 2018.

The facility is located in the drainage area of the Double Mountain Fork Brazos River in Segment No. 1241 of the Brazos River Basin.
