## Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG920592

**Application.** David Robert Lee May, 2930 County Road 412, Campbellton, Texas 78008 has applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicant is proposing to reconfigure the land management units (LMUs) and decrease the total land application area from 2,324 to 1,942 acres. The table below shows the current and the proposed LMUs and acreage.

The notice of change application and the updated NMP were received by TCEQ on November 21, 2017.

No discharge of pollutants into the waters in the state is authorized by this general permit except under chronic or catastrophic rainfall conditions or events. All waste and wastewater will be beneficially used on agricultural land.

The facility is located at 2930 County Road 412, Campbellton, Atascosa County, Texas. The facility is located in the drainage area of the Atascosa River in Segment No. 2107 of the Nueces River River Basin.
