Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG921369

Application. Eastside Dairy, LLC, P. O. Box 1300, Dumas, Texas 79029 has applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicant is proposing to decrease the acreage of land management unit #3 from 200 to 180 acres to incorporate calf barns, silage storage areas and retention control structure (RCS) #6. The total land application area has decreased from 4,880 to 4,860 acres. Another change includes the addition of new wells, plugging of some existing wells and update to the facility maps. Moreover, the Applicant is proposing to transfer wastewater from this dairy to a covered digester located in another dairy facility, Westside Jerseys, LLC with Authorization # TXG921322 located at <http://www.tceq.texas.gov/assets/public/hb610/index.html?lat=36.0275&lng=-102.0899&zoom=13&type=r> to recover gas for beneficial use. The design calculations for the RCS Runoff R5 have been revised to include the calf barns and RCSs T1, T2, & T5 have been revised to include the use of the covered digester in lieu of the treatment volume for odor control. The currently authorized total dairy cattle of 92,000 head, of which 17,000 head are milking cows remains unchanged. The notice of change application and the updated NMP were received by TCEQ on August 13, 2018.

No discharge of pollutants into the waters in the state is authorized by this general permit except under chronic or catastrophic rainfall conditions or events. All waste and wastewater will be beneficially used on agricultural land.

Eastside Dairy, LLC is located at 5501 Farm-to-Market Road 281, Dumas, Moore County, Texas. The facility is located in the drainage area of the Canadian River in Segment No. 0100 of the Canadian River Basin. The Executive Director of the TCEQ has approved the proposed non-substantial change to the terms of the NMP. The revised terms of the NMP have been included in the permit record and it is available at the TCEQ's Central Records, 12100 Park 35 Circle Austin, Texas 78753.
