Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG921355

Application. Hartley Farms, LLC, P.O. Box 1300, Dumas, Texas 79029 has applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicant has renamed the land management units (LMU) and decreased the acreage of LMU #123 (formerly LMU S-9) from 440 to 320 acres to incorporate one retention control structure (RCS) RCS #5. The facility maps were updated to show the location of RCS #4 (for south hutch area) that was previously approved and all proposed changes to the dairy. The RCS design calculations were revised, and former slurry storage pits were modified to act as a covered digester system (RCS T3) for recovering methane gas for beneficial use. The total land application area has decreased from 5,557 to 5,437 acres. The notice of change application and the updated NMP were received by TCEQ on September 13, 2019.

The facility is located at 1.75 miles east of intersection of Farm-to-Market Road 807 and Farm-to-Market Road 2577 on the south side of Farm-to-Market Road 2577, Hartley in Hartley County, Texas. The facility is located in the drainage area of the Canadian River in Segment No. 0100 of the Canadian River Basin.
