Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG921503

Application. Exum Farms, LLC, P.O. Box 1300, Dumas, Texas 79029 has applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicant has renamed the land management units (LMUs) without changing the acreage of the LMUs, revised the facility retention control structure design (RCS) calculations to use a covered digester (RCS T1) in lieu of a treatment volume for odor control, updated the facility maps based on the construction and proposed construction in the production area, and updated the property boundary based on legal survey information. RCS T1 will receive the wastewater from this facility (TXG921503 located at latitude 36.023888° North and longitude 102.176111° West) and Exum Farms West (TXG921482 located at latitude 36.025277° N and longitude 102.200277° W) to recover gas for beneficial use. The currently authorized maximum capacity of 135,650 head, of which 38,000 head are milking cows and a total land application area of 3.526 acres remain unchanged. The table below includes the current and proposed LMU name and acreage. The notice of change application and the updated NMP were received by TCEQ on January 17, 2020.

No discharge of pollutants into the waters in the state is authorized by this general permit except under chronic or catastrophic rainfall conditions or events. All waste and wastewater will be beneficially used on agricultural land.

The facility is located 10.5 miles west on highway 281 from the intersection of highway 281 and highway 287 in Cactus, Hartley County, Texas. The facility is located in the drainage area of the Canadian River in Segment No. 0100 of the Canadian River Basin.
