Notice of Concentrated Animal Feeding Operation Application General Permit Authorization No. TXG921584

Application. Jordan David Whaley, Karen Joy Whaley, and Thousand Hills Farms, LLC, 1250 County Road 334, Dublin, Texas, 76446 have applied to the Texas Commission on Environmental Quality (TCEQ) under General Permit No. TXG920000 for a non-substantial change to the terms of the nutrient management plan (NMP) previously submitted to the TCEQ. The Applicant is proposing to remove the offsite calf ranch that is located 3.2 miles northwest of the production area of this heifer replacement facility at Latitude: 32.015753° North and Longitude: 98.352336° West; which will remove Land Management Units (LMUs) #5 (30 acres), #6 (64 acres), Retention Control Structures (RCSs) #CR 3, and #CR 4 from this authorization. The removed calf ranch (including the LMUs and the RCSs) will be added to another authorization TXG921276. Another proposed change is the adjustment to the onsite property boundary which will remove (LMUs) #3 (55 acres), #4 (32 acres), and part of LMU #2 (which decreased the acreage from 27 to 10 acres). LMU #1 has been reconfigured (which decreased the acreage from 62 to 61 acres). The total land application area is decreasing from 270 to 71 acres. The design calculations for RCS #3 and #4 were updated to add pen areas which changed the drainage area. The facility maps have been updated to reflect these changes. The notice of change application and the updated NMP were received by TCEQ on June 4, 2021.

No discharge of pollutants into the waters in the state is authorized by this general permit except under chronic or catastrophic rainfall conditions or events. All waste and wastewater will be beneficially used on agricultural land.

The facility is located at 925 County Road 330, Dublin in Erath County, Texas. The facility is located in the drainage area of the Leon River Below Lake Proctor in Segment No. 1221 of the Brazos River Basin.
