#### NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN WATER QUALITY PERMIT RENEWAL

#### PERMIT NO. WQ0014211001

**APPLICATION.** Acton Municipal Utility District, 6420 Lusk Branch Court, Granbury, Texas 76049, has applied to the Texas Commission on Environmental Quality (TCEQ) to renew Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0014211001 (EPA I.D. No. TX0105163) to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 930,000 gallons per day. The domestic wastewater treatment facility is located at 4300 Cimmaron Trail, in Hood County, Texas 76049. The discharge route is from the plant site to McCarty Branch; thence to Lake Granbury. TCEQ received this application on December 19, 2023. The permit application will be available for viewing and copying at Acton Municipal Utility District Office, 6420 Lusk Branch Court, Granbury, Texas prior to the date this notice is published in the newspaper. **ADDITIONAL NOTICE.** TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. **Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.** 

**PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting on this application.** The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a

response to all relevant and material, or significant public comments. Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period and, the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.

**MAILING LIST.** If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.

#### DOMESTIC WASTEWATER

The following summary is provided for this pending water quality permit application being reviewed by the Texas Commission on Environmental Quality as required by 30 Texas Administrative Code Chapter 39. The information provided in this summary may change during the technical review of the application and are not federal enforceable representations of the permit application. The Acton Municipal Utility District (CN600647945) operates Wastewater Treatment Facility 1 at DeCordova Bend, RN102898459,. a domestic wastewater treatment plant. The facility is located at 4300 Cimmaron Trail, in Acton, Hood County, Texas 76049.

The Acton Municipal Utility District has applied for a minor amendment with renewal of the existing permit that authorizes the discharge of treated domestic effluent at a daily average flow not to exceed 0.60 million gallons per day in the Interim Phase and a daily average flow not to exceed 0.93 million gallons per day in the Final Phase. The facility is operating in the Interim Phase. The minor change removes proposed equalization basin 1 from the Final Phase.

Discharges from the facility are expected to contain Carbonaceous Biological Oxygen Demand 5-day, Total Suspended Solids, Ammonia Nitrogen, and E. Coli. Domestic wastewater is treated by an activated sludge process plant operated in the extended aeration mode in the Interim Phase. In the Final Phase the facility will convert to a Sequencing Batch Reactor plant.

### Spanish PLS:

Acton Municipal Utility District (CN600647945) opera la instalación de tratamiento de aguas residuales domésticas WWTF 1 at DeCordova Bend (RN102898459). La instalación está ubicado en el 4300 Cimmaron Trail, en Acton, Condado de Hood, Texas 76049.

Acton Municipal Utility District ha solicitado una enmienda menor con renovación del permiso existente que autoriza la descarga de efluentes domésticos tratados a un flujo promedio diario que no exceda los o,6 millones de galones por día en la fase intermedia y a un flujo promedio diario que no exceda los o,93 millones de galones por día en la fase final. La instalación está operando en la fase intermedia. El cambio menor elimina la cuenca de ecualización 1 propuesta de la fase final.

Se espara que las descargas de la instalación contengan demanda biológica carbonosa de oxígeno de 5 días, sólidos suspendidos totales, nitrógeno amoniacal y E. coli. Las aguas residuales domésticas se tratan mediante una planta de lodos activados que funciona en modo aireación extendida en la fase intermedia. En la fase final, la instalación se convertirá en una planta reactor discontinuo secuencial (SBR).
